- 2. Our building experts are retiring! According to the U.S. Bureau of Labor Statistics, nearly 1 in 4 construction workers are older than 55, and retirements will continue to whittle away at the workforce.
- 3. We're running our people ragged! Workers in the construction industry are more vulnerable to burnout than in any other field. In 2017, the National Association of Home Builders found that only 3% of people aged 18 to 25 wanted to work in construction.


