# Governor Newsom shares California's economic vision and budget

Governor Newsom continued his statewide California Jobs First tour today to outline a first-of-its-kind, bottom-up economic vision for California's future, receiving the regional plan from local leaders in the North San Joaquin Valley.The Governor also previewed toplines of this year's state budget — a balanced spending plan that makes government more efficient, increases accountability, and improves the safety, health, and well-being of Californians.

Governor Gavin Newsom, as part of his ongoing statewide California Jobs First tour, today received the North San Joaquin Valley's regional economic plan from community leaders representing San Joaquin, Stanislaus, and Merced counties. The plan is one of 13 regional plans that will make up the upcoming California Jobs First Economic Blueprint.

Governor Newsom also previewed his 2025-26 state budget proposal by outlining the state's continued plans to support robust economic growth, high-paying jobs and career development, and strong accountability measures to address housing, homelessness, and mental health.

California is not only dominating but paving the way for the future of jobs and the American economy, with local homegrown economic

plans for every region of our state. With a balanced budget and key investments maintained for the upcoming fiscal year, we are well-positioned to continue the forward momentum we have created. California remains the standard bearer for our nation, and we're looking forward to another strong year ahead.

#### California Jobs First

The California Jobs First Economic Blueprint will guide the state's investments in key sectors to drive sustainable economic growth, innovation, and access to good-paying jobs over the next decade. The complete Economic Blueprint will be released in the coming weeks, along with a grant solicitation for a portion of the remaining \$120 million over three years in competitive funding to support "ready-to-go" projects aligned to the state's strategic sectors, ensuring that every region across California continues to play a critical role in the sustainable growth of the world's fifth largest economy.

Made up of ten key industry sectors, this framework will help streamline the state's economic, business, and workforce development programs to create more jobs faster. The state's thirteen economic regions engaged more than 10,000 local residents and experts who collectively identified these sectors as key to driving local economies into the future.

"As Chair, I brought New Hampshire voices to Washington to share their insight on key challenges faced by Granite State—and America's small business owners, moving key legislation through the negotiation process and out of com-

mittee," said Chair Shaheen. "I will remain a senior member of the committee and will continue to fight for bipartisan support on issue areas like reauthorizing the State Trade Expansion Program (STEP), promoting legislation that helps lower costs for small business owners and addressing the challenges small businesses face with child care, including the challenges small business child care providers themselves face."


During her time as Chair of the committee, Shaheen fought for New Hampshire's-and America's-small businesses. Shaheen was laser-focused on addressing some of the biggest challenges small business owners face, reporting key legislation out of committee that included critical improvements to STEP and improved access to federal contracting opportunities for small businesses

#### Fighting for Granite State Small Businesses

Shaheen included \$4.5 million for individual projects supporting small business development across the Granite State in Fiscal Year 2025 funding that passed the Senate Appropriations Committee unanimously, in addition to more than \$100 million in Congressionally Directed Spending in the fiscal year 2024 government funding bills to address New Hampshire needs including housing, health care and education.

#### **Lowering Costs for Small Businesses**

Shaheen hosted a state field hearing and resource fair at the University of New Hampshire at Manchester on historic investments from the Bipartisan Infrastructure Law and the Inflation Reduction Act that can help small businesses

# San Francisco helps over 17,000 workers with labor enforcement and restitution.

The San Francisco Office of Labor Standards Enforcement (OLSE) announces assisting over 17,000 workers in Fiscal Year 2024, the highest number assisted since the office's inception in 2001

OLSE, a division within the Office of the City Administrator, is dedicated to protecting the rights and welfare of San Francisco's workers. This year, the office resolved over 400 cases, recovering more than \$16 million in restitution and fees. Through enforcing labor laws, addressing worker complaints, and conducting proactive outreach to both workers and employers, OLSE continues to ensure fairness and accountability across the city.

San Francisco has consistently set the standard for protecting workers' rights. It was the first city in the nation to establish a local minimum wage.

paid sick leave, paid parental leave, and healthcare access for employees. Today, more than 60 cities have adopted similar policies, like our paid sick leave policy, building on the trailblazing framework created in San Francisco.

This year, OLSE partnered with the U.S. Department of Labor and the California Division of Labor Standards Enforcement in its first interagency enforcement action. Through this triagency initiative, over \$900,000 was successfully recovered, benefiting more than 38 workers. This collaboration highlights the importance of coordinated efforts to uphold workers' rights and ensure accountability for labor law violations.

"The work of the Office of Labor Standards Enforcement has a tangible and lasting impact on the lives of our city's workers. This year is no exception with the staff resolving a record number of cases and providing assistance to over 17,000 workers," said City Administrator Carmen Chu. "Under the leadership of Pat Mul-

ligan, I continue to be impressed by and want to thank the OLSE team for the commitment and urgency they show in upholding workers' rights and to ensuring workers receive the compensation they are owed."

Year after year, OLSE centers San Francisco workers by enforcing the trailblazing and comprehensive legislation passed through the Board of Supervisors and San Francisco voters.

In the last fiscal year alone, the Office of Labor Standards Enforcement has:

- Rolled out the first San Francisco Labor and Employment Code which establishes labor standards within the city, encompassing various ordinances that set minimum wages, mandate paid sick leave, and ensure health care security, among other worker protections.
- Implemented the Transfer Tax Reduction for Union Labor-Built and Union Pension

Fund-Financed Housing Ordinance which can reduce real property transfer tax rates in high-value residential rental properties if they meet specific criteria.

Operationalized the Housing Production –
Prevailing Wage requirements on Certain
Housing codes law which mandates that
workers involved in specific housing development projects on city-owned or leased
properties receive wages equivalent to the
prevailing rates for their respective trades.

"I am proud of the OLSE team for fostering a culture of compliance that protects workers and ensures fairness for employers. By implementing new efficiencies OLSE will continue to strengthen worker protections and address new challenges," said Patrick Mulligan, Director of the Office of Labor Standards Enforcement.

lower their energy costs, transition to the clean energy economy and build resilience. Following the field hearing, small businesses participated in a resource fair and met with federal agencies and state business support programs.

Shaheen also worked with Senator Cassidy (R-LA) to introduce the bipartisan Helping Small Businesses to Hedge Risk and Insure against Volatile Expenses (Helping Small Businesses THRIVE) Act. The bill directs the Small Business Administration (SBA) to create a program that helps small businesses lock in the cost of commodities, like gasoline or lumber, in order to protect against inflation.

#### **Addressing Child Care Workforce Issues**

Shaheen convened a hearing that featured testimony from expert witnesses on the child care industry's broken business model and what Congress can do to support small business child care providers, employees and families. In the New Hampshire Business Review, Shaheen shined a light on the importance of ensuring access to affordable and high-quality child care for

women entrepreneurs. Shaheen continues to call for Congress to pass legislation that addresses America's child care crisis, including her Right Start Child Care and Education Act to improve the tax code to help make child care more affordable and accessible for working families, as well as her bipartisan Expanding Access to Child Care for Military Families Act. She also highlighted an SBA issue brief that offers a clear picture of the many small business challenges that increase child care costs for working families.

#### **Improving Support for Rural Small Businesses**

Shaheen joined U.S. Senator John Kennedy (R-LA) to introduce bipartisan legislation that improves support for rural small businesses and convened a hearing to hear from witnesses who discussed the challenges that rural small businesses face and how federal efforts to streamline services can help their firms grow.

## **Expanding Export Opportunities for Small Businesses**

Shaheen hosted a field hearing and resource fair at the University of New Hampshire on programs and resources, including STEP, available

for Granite State small businesses to compete in the global marketplace. Shaheen later celebrated the first cohort of graduates from the New Hampshire Export Accelerator, a program funded through STEP, and highlighted a \$500,000 STEP award from the SBA to help Granite State small businesses tap into international markets.

#### **Supporting Veteran Entrepreneurs**

Shaheen introduced legislation to expand access to credit for veteran entrepreneurs and convened a hearing on the state of veteran small business ownership. In the National Defense Authorization Act (NDAA) for Fiscal Year 2025, Shaheen worked to include several provisions that support small businesses, including codifying SBA's Boots to Business program, which offers entrepreneurial training to service members, military spouses, veterans and National Guard and Reserve members.

# Bringing New Hampshire Voices to Washington and Increasing Access for Disabled Entrepreneurs

In her first three months as Chair, Shaheen invited Granite State small businesses to Washington for their testimony on America's outdoor recre-

ation economy and small business succession planning. Shaheen also worked across the aisle to introduce bipartisan legislation that expands support for disabled entrepreneurs.

# **Shining a Spotlight on Small Businesses in the Outdoor Recreation Economy**

In her first hearing as Chair, Shaheen highlighted the key role small businesses in New Hampshire and around the country play in America's outdoor recreation economy. The outdoor recreation economy supports 5 million jobs and generates \$1.2 trillion in economic output, according to the most recent data published by the U.S. Department of Commerce's Bureau of Economic Analysis (BEA). That data is collected thanks to Shaheen's bipartisan Outdoor Recreation Jobs and Impact Act of 2015 with former Senator Cory Gardner (R-CO) that was signed into law in 2016.

# Governor Newsom shares California's economic vision and budget

#### Jobs in the North San Joaquin Valley

Today, leaders in the North San Joaquin Valley region presented their regional plan to the Governor and provided information about their key economic sectors:

- Advanced Manufacturing, including building materials, mobility technologies, and measurement and testing products
- Clean Economy, particularly solar energy, green hydrogen, biofuels, and carbon management, an emerging sector with enormous growth potential, driven by the increasing demand for carbon capture and sequestration technologies.
- Bioeconomy, a forward-looking sector that is transforming waste streams from biomass (such as agricultural and forestry residues, municipal solid waste, and food processing byproducts) into valuable bioproducts such as fuels, plastics, chemicals, solvents, fabrics, polymers, food additives, and alternative proteins.

#### A balanced budget and a more efficient government

Continuing to deliver key investments and responsible fiscal management, Governor Newsom previewed the toplines of his 2025-26 state budget proposal - a balanced budget that emphasizes fiscal stability and lean and efficient government. The full budget release, accompanied by a briefing led by the Department of Finance, is scheduled for Friday, January 10, 2025.

The Governor's \$322.2 billion proposal includes \$228.9 billion in general fund spending. The proposed budget is fully balanced with no deficit and projects \$16.5 billion in additional revenue above the 2024 Budget Act thanks to a stronger economy, stock market, and cash receipts. It includes savings from the elimination of 6,500 government positions, resulting in \$1.2 billion in savings over two years, alongside operational efficiencies like reduced travel budgets, printing costs, and IT modernizations that further reduce costs by \$3.5 billion.

### **Mayor Breed Announces \$36 Million in Grants for Transit Infrastructure & Street** Safety Upgrades

Mayor London N. Breed announced \$36 million in new funding awarded by the Metropolitan Transportation Commission (MTC) in Housing Incentive Pool Grants that will support critical infrastructure projects in San Francisco. The Housing Incentive Pool provides infrastructure grants to promote the production and preservation of affordable housing.

The City of San Francisco was awarded \$35.8 million in funding after building 2,981 qualifying affordable housing units between 2018 and 2022. Funding will support infrastructure improvements, including new traffic signals on Lincoln Way, Folsom and Howard Street improvements, Powell Street streetscape changes, and Yerba Buena Island (YBI) West Side Bridges improvements. Funding will also go to improving the state of the city's bus fleet to make transit service more reliable.

"This funding is essential to continue our work in making transit more reliable and our streets safer for all," said Mayor London Breed. "Whether we are maintaining our buses, improving bike lanes, or installing traffic signals to improve traffic flow, we are making transit more efficient, effective, and safer for

"I know the traffic headaches and transit delays down Lincoln Way and into Golden Gate Park are a significant quality of life issue for westside residents," said Sunset District Supervisor Joel Engardio. "This critical funding for infrastructure improvements will help

Sunset and Richmond residents get where they need to go.'

"We're so grateful for this capital grant, because it allows us to continue funding critical safety and economic recovery projects even as we work to close the gap in our operating budget," said Jeff Tumlin, SFMTA Director of Transportation.

### Lincoln Way Traffic Signal Improvements

This project will include the construction of new signals at two intersections (Lincoln/45th Avenue, Lincoln/La Playa) to reduce vehicle and transit delays on Lincoln Avenue and improve pedestrian and bicycle access to the new Ocean Beach Park. These improvements are part of a broader westside transportation planning program currently underway to identify and recommend infrastructure upgrades on key traffic corridors in the Sunset and Richmond.

These two new signals would replace existing STOP controlled intersections and will be constructed in conjunction with a new traffic signal already planned to replace a STOP sign at 41st and Lincoln and a traffic signal upgrade at Great Highway at Lincoln. This new infrastructure along the Lincoln Way corridor will ensure there are safe signalized intersections between the Sunset neighborhood and Golden Gate Park, from the Great Highway to Sunset Boulevard. Improvements will include new curb ramps and streetlights.



# The Stigma of Choosing Trade School Over College

Toren Reesman knew from a young age that he and his brothers were expected to attend college and obtain a highlevel degree. As a radiologist—a profession that requires 12 years of schooling—his father made clear what he wanted for his boys: "Keep your grades up, get into a good college, get a good degree," as Reesman recalls it. Of the four Reesman children, one brother has followed this path so far, going to school for dentistry. Reesman attempted to meet this expectation, as well. He enrolled in college after graduating from high school. With his good grades, he got into West Virginia University—but he began his freshman year with dread. He had spent his summers in high school working for his pastor at a custom-cabinetry company. He looked forward each year to honing his woodworking skills, and took joy in creating beautiful things. School did not excite him in the same way. After his first year of college, he decided not to return.

He says pursuing custom woodworking as his lifelong trade was disappointing to his father, but Reesman stood firm in his decision, and became a cabinetmaker. He says his father is now proud and supportive, but breaking with family expectations in order to pursue his passion was a difficult choice

for Reesman—one that many young people are facing in the changing job market.

Traditional-college enrollment rates in the United States have risen this century, from 13.2 million students enrolled in 2000 to 16.9 million students in 2016. This is an increase of 28 percent, according to the National Center for Education Statistics. Meanwhile, trade-school enrollment has also risen, from 9.6 million students in 1999 to 16 million in 2014. This resurgence came after a decline in vocational education in the 1980s and '90s. That dip created a shortage of skilled workers and tradespeople.

Many jobs now require specialized training in technology that bachelor's programs are usually too broad to address, leading to more "last mile"—type vocational-education programs after the completion of a degree. Programs such as Galvanize aim to teach specific software and coding skills; Always Hired offers a "tech-sales bootcamp" to graduates. The manufacturing, infrastructure, and transportation fields are all expected to grow in the coming years—and many of those jobs likely won't require a four-year degree.

### **Building Green, Green Hotels**

San Francisco's first truly eco-friendly hotel is "green" from the ground floor to the rooftop.

The Orchard Garden Hotel was the first California hotel awarded LEED (Leadership in Energy & Environmental Design) certification by the U.S. Green Building Council. The Orchard Garden is the third hotel in the U.S. and fourth hotel in the world with this certification.

The Orchard Garden achieved LEED certification in part with its effective building envelope and core system. The building envelope helps reduce energy consumption through its high albedo (ability to reflect the sun's rays) roof coating, well insulated exterior walls, and effective use of daylighting (window placement to allow more natural light in during the day, eliminating the need to turn on a light switch). Green and high albedo materials constitute more than 75% of the roof area; this lowers the amount of energy needed to cool the building. The hotel has daylighting in more than 82% of the occupied areas.



The Orchard Garden Hotel in San Francisco (pictured above) saves an estimated 20% of their energy bill yearly from energy efficient procedures.


