

# California's High-Speed Rail Program Celebrates Progress and Highlights Next Steps Towards Operations

Governor Gavin Newsom, California High-Speed Rail Authority (Authority) CEO Ian Choudri and community leaders, officially kicked off the Authority's Railhead Project in Kern County commemorating the first steps in the track and systems construction process. This work is made possible due to the substantial completion of Construction Package 4 (CP 4), the southernmost segment of high-speed rail construction in California's Central Valley.

In an effort to deliver a southwest regional high-speed rail network, the Authority, Brightline West and the High-Desert Corridor Joint Powers Agency have been working closely, ensuring coordination of technical and operational significance to ultimately enable an interoperable system that connects riders to and from Las Vegas to California's high-speed rail system in Southern California.

### About the Railhead Project

Construction of the railhead is a major step in the track and systems process and signifies the next phase of the high-speed rail program bringing it closer to operations. The Railhead Project is necessary for the Authority to receive materials to start construction of temporary freight tracks, which includes de-

livery of major equipment such as track laying machines, track ties, traction power and Overhead Contact Systems (OCS). The work starts with a period of subgrade preparation, readying the site for the eventual laying of ballast ties and rail for the yard, effectively serving as a location to receive materials required to build the Authority's high-speed rail track. The Authority will be issuing a Request for Proposals to procure a contract for Track and OCS construction in 2025.

### About Construction Package 4

Construction Package 4 (CP 4) External Link is a 22-mile stretch of the high-speed rail project between Poplar Avenue in Wasco and approximately one mile south of the Tulare/Kern County line. The Authority contracted with California Rail Builders to construct all high-speed rail structures located within this segment, which includes 11 civil structures comprised of overpasses, underpasses, and viaducts built to take high-speed trains over roadways, waterways, and existing rail lines. Of the more than 14,500 construction jobs created since the start of the high-speed rail project, work in CP 4 generated more than 3,200 jobs that went to residents of the Central Valley, the majority going to workers in Kern County.

## Recession No More: 2025 Construction Economic Forecast Yields Positive Outlook

On Dec. 11, 2024, Construction Executive presented its final economic webinar of the year. ## MINORITY BUSINESSES ON THE RISE

### California boasts third-highest rate of minority-owned businesses in the U.S.

- California places third in the study, averaging 28.46 minority-owned companies per 1,000 minority residents.
- Asian-owned businesses represent 169,863 of the 278,770 minority-owned businesses statewide.
- Wyoming ranks top with 34.53 minority-owned businesses for every 1,000 minority people in the state.

California has the third-highest rate of minority-owned businesses in America, a new study has found.

The experts at Baldwin Digital analyzed data from the 2021 U.S. Census on businesses owned by members of racial minority groups. These figures were compared with non-white population data to reveal which states had the highest rate of minority-owned businesses per 1,000 minority residents.

California takes the third spot overall. For every 1,000 minority people in the Golden State, there are 28.46 minority-owned businesses. Of the 278,770 businesses owned by a minority, more than 60% (169,863) belong to a member of the Asian community. There are 15,014 Black or African American-owned businesses and 9,593 American Indian and Alaska Native-owned businesses.

Wyoming ranks at the top of the study with the highest number of minority-owned businesses per 1,000 minority residents, at 34.53. The state is home to 1,376 minority-owned companies, with more than one in three (or 543) run by a member of the Asian community. American Indians and Alaska Natives have the second-most businesses of any minority race in the state with 152.

Florida ranks second in the study, with an average of 31.28 minority-owned businesses per 1,000 minority residents. Approximately 137,804 firms statewide are registered to non-white owners. Asian-owned businesses comprise 34,284 of the total while Black or African American is the race with the second-most companies (18,502), the highest number nationwide.

New Mexico places fourth for minority-owned businesses, with 26.25 per 1,000 minority residents. Approximately 8,172 businesses are recognized as having an owner from a racial

minority group, with 1,650 operated by Asian residents and 403 by American Indian and Alaska Native residents.

Colorado rounds out the top five states with the highest rate of minority-owned businesses. For every 1,000 people from a racial minority group, the state is home to 25.70 minority-owned businesses. Asian is the racial minority with the most businesses statewide, with 6,636, followed by Black or African American (1,571).

Ranking sixth overall, Texas averages 23.93 minority-owned businesses per 1,000 minority population. The state has 140,402 businesses in this category, second nationwide only to California. Approximately 62,350 of these companies are owned by a member of the Asian community.

Oregon ranks seventh in the study. Of every 1,000 people from a racial minority, the state averages 23.67 minority-owned businesses. In total, 12,721 minority businesses operate state-wide, with the number comprised of 6,320 Asian-owned firms, 1,570 American In-

dian and Alaska Native firms, and more.

Idaho has 22.97 minority-owned businesses per 1,000 minority residents, securing the state's eighth-place position. Asian-led companies are the most popular statewide, representing 1,332 of the total 2,817 minority-led businesses.

Utah cements its place as ninth overall with 22.61 minority-owned businesses per 1,000 minority population. Asian, American Indian and Alaska Native, and Black or African American are the most popular racial minority businesses in the state.

New York is the final state to be named in the 10 states with the highest rate of minority-owned businesses. Home to 109,028 minority companies, the state averages 20.49 per 1,000 minority population. More than 65% of these businesses (72,840) are Asian-owned, while Black or African American individuals own 13,953 businesses.

Mississippi and South Dakota have the lowest rates of minority-owned businesses in the

country, with each state averaging 4.65 and 6.18 companies per 1,000 minority residents, respectively.

Mark Baldwin, director and founder of Baldwin Digital Ltd, commented on the study, "The West appears to be the best region for minority-owned businesses, with seven of the 10 states with the highest rates located there.

"Minority business owners in America can receive support from several avenues to help give their ventures a better chance of success. Support includes government grants, Minority Business Development Agency (MBDA) grants, financial consultations, and the National Minority Supplier Development Council's Business Consortium Fund."

This new mixed-use development will be located at 1123 Sutter on an approximately 29,700sf site, currently occupied by two structures: an auto repair shop with public garage (at 1101 Sutter) and a mortuary (at 1123 Sutter). At the west side of the site, the mortuary will be removed for new construction of a 22-story high-rise tower. This high-density development will utilize the individually requested state density bonus program to increase the number of code-permitted units from 149 to 286. In total, the pair of buildings will provide 303 new homes, including 38 below-market-rate units. These new units will be offered on a rental basis. The building is set back from the alley at various distances to accommodate the entry court, an outdoor area for the child-care center, private terraces and balconies, and access to the garage and loading entries. Midway up the tower, on the 7th floor, the building steps back ~40 feet on the west side, to provide a shared landscaped area at this setback. At the 21st floor, another step back is incorporated to create an outdoor landscaped terrace. Additionally the top (22nd) floor provides shared viewpoints, a number of building services, and a community room with associated outdoor roof deck.

### Biden-Harris Administration Awards Additional \$210 Million Tech Hub Grants

The U.S. Department of Commerce's Economic Development Administration (EDA) announced today that it plans to award approximately \$210 million in implementation grants, ranging between approximately \$22 million and \$48 million, to six Tech Hub Designees as part of a new round of funding from Congress. In addition, EDA intends to partner with the U.S. National Science Foundation (NSF) to extend tailored resources and personalized support to Tech Hubs. This builds on the July 2024 announcement of \$504 million for 12 Tech Hubs across America, bringing the total to more than \$700 million for 18 centers of excellence focused on jobs and industries of the future.

The six latest Hubs selected for implementation grants are among the 31 Tech Hubs designated in October 2023 by President Biden to scale up the production of critical technologies, create jobs in innovative industries, strengthen U.S. economic competitiveness and national security, and accelerate the growth of industries of the future in regions across the United States.

"To out-innovate and out-build the rest of the world, we need to ensure we're investing in America's talent and workforce to succeed in

a 21st century economy – that's how America maintains its competitive edge," said U.S. Secretary of Commerce Gina Raimondo. "The Tech Hubs Program and this latest allocation of funds are the result of bipartisan cooperation in Congress – I hope that good-faith work will endure so we can continue to invest in these centers of excellence across the nation, which in return, are providing good-paying jobs in industries of the future and helping to strengthen U.S. economic and national security."

"We are so pleased that bipartisan support in Congress for the Tech Hubs Program will allow us to make even more impactful investments in the future of America's economy and national competitiveness," said Cristina Killingsworth, Acting Assistant Secretary of Commerce for Economic Development. "This implementation funding will empower the six Tech Hubs to spur technology commercialization, create jobs, attract private investment, and fortify their regional economy as a global leader in their respective technology focus."

These new awardees, all designated Tech Hubs that have not previously received Tech Hubs implementation funds, made a strong case that with targeted investment they can advance a critical technology important to American economic

and national security. This new round of awards is funded by new appropriations from the Fiscal Year (FY) 2025 National Defense Authorization Act (NDAA). The NDAA also includes a provision that could provide the Tech Hubs Program additional funding of up to \$280 million in the coming years.

About the collaboration between the High-Speed Rail Authority, Brightline West, and High-Desert Joint Powers Agency

The Authority, High-Desert Corridor Joint Powers Agency and Brightline West have been working together in close collaboration to develop the U.S. Southwest region high-speed rail network. Once fully built and interconnected, the three high-speed rail systems will pave the way for Californians to travel from Northern California through Central Valley to Southern California, as well to Las Vegas. The three parties continue to collaborate on protocols and standards for interoperability between systems.

In California's Central Valley, there are 25 active construction sites, more than 60 miles of guideway completed and nearly five miles of bridges and other structures in place, making it possible to begin the track laying construction process. In addition, 463 of 494 miles have been fully environmentally cleared for the high-speed rail project between the Bay Area and Los Angeles County.

High-speed rail is a key part of Governor Newsom's Build More, Faster agenda, delivering infrastructure upgrades and creating jobs throughout the state.

## California's Workforce Is Diverse, but Many Occupations Are Not

Despite California's highly diverse workforce, many types of jobs are predominantly filled by people from a specific demographic group, making them almost homogenous. In fact, this phenomenon—sometimes known as occupational segregation—is so widespread in California that it is a major feature of even the largest occupations. Moreover, many occupations outside of the top ten are even more homogenous. Here we highlight the jobs in California where occupational segregation is most extreme, particularly along the intersecting lines of gender and race/ethnicity.

Some of the most demographically skewed occupations are uneven by gender: in manual trades like carpentry and plumbing, practically all workers are men. Pre-K teaching and child-care work are similar, but in reverse, with the

former skewing toward white women and the latter toward women of color.

Meanwhile, for racial/ethnic groups, about 90% of workers in some agricultural and landscaping jobs are Latino, and 75% or more of other agricultural workers, as well as maids and house-keeping cleaners, are immigrants.

White workers also see heavy overrepresentation in some fields, but to a lesser extent: producers and directors, firefighters, and CEOs and legislators are about twice as likely to be white as the overall workforce (60 to 68% in these jobs are white, compared to about 33% of full-time, full-year workers).

Racial/ethnic groups that make up smaller percentages of California's workforce—Black, Asian/Pacific Islander, and other categories—experience as much or more overrepresentation in certain jobs as white and Latino workers do in others, even if they never make up 90% of

an occupation. Security guards and personal care aides are more than twice as likely to be Black as the average full-time worker (24% and 12% of those occupations, respectively, but just 5% of all full-time workers), and software developers are more than twice as likely to be Asian/Pacific Islander (57% of this job, but 18% overall).

Notably, not all jobs are so heavily skewed. For example, sales supervisors and compliance workers are similar to the overall workforce in racial/ethnic composition, and managers (the state's largest job category) are representative in terms of gender.

Skills and education factor into the jobs that Californians take on, and higher education in particular continues to lead to higher paid work; addressing race- or gender-based disparities in access to education could thus make some occupations less homogenous. At the same time, as we have noted elsewhere, demographic over-

and underrepresentation in jobs also reflect disparities in areas like labor market opportunities and social supports that are tied to historical race- and gender-based discrimination. These factors collectively contribute to the fact that workers who are Black, Latino, "other race," female, or immigrants typically earn lower hourly wages. Given the problem's long roots, addressing barriers to job access is complex but could benefit individuals seeking upward mobility as well as businesses in search of a skilled workforce.

Building skills and educational attainment could widen Californians' job choices, and according to the November 2023 PPIC Statewide Survey on Californians' economic well-being, educational policies are quite popular: 81% of Californians support job training programs and about seven in ten favor making public college tuition-free (68%).

# Mayor Daniel Lurie to welcome JP Morgan Healthcare Conference back to San Francisco

## Conference generates tens of millions of dollars for city's economy

Mayor Daniel Lurie will welcome more than 8,000 visitors to San Francisco at the JP Morgan Healthcare Conference, kicking off his first full week in office.

Mayor Lurie's work to end the three-month hotel workers' strike was critical to enabling the conference to move forward in the city as planned.

In his remarks, Mayor Lurie will discuss his work to provide public safety and clean streets, kickstarting San Francisco's revitalization, and urge conference attendees to be active participants. "San Francisco is open for business," he will say. "I'm inviting you, as industry leaders, to not just witness our comeback, but to be part of it."

## Below are key excerpts from Mayor Lurie's prepared remarks:

*"It's hard to believe there was ever a debate about this conference being here. San Francisco has long shaped the future of healthcare and technology.*

*"Yes, we've faced challenges recently. We own that. But this past November, San Franciscans made it clear that we're ready for change.*

*"It's a new day in San Francisco.*

*"Under my administration, we are facing our issues head-on, with urgency, and an unapologetic focus on results.*

*"That's how we ended the longest hotel strike in city history and got San Franciscans back to work and the hotel industry up and running in time for you to join us here today.*

*"At this very moment, San Francisco is at an inflection point. And in this new era, our potential has no ceiling."*

## Lopes Family Farms

Bruce and Christopher Lopes realized they needed to pivot from their old business model to something that could sustain the family long into the future because the rising costs of farming, unpredictable weather and wildly fluctuating commodity prices were leading them towards going out of business. The father and son team adapted their new practice from the Japanese style of duck rice farming due to its potential for sustainability.

The Lopes started their business out of their 113-year-old rice farm with the goal of entering the direct-to-consumer market and spreading awareness of their regenerative/organic farming practice. They had a great idea for how to turn things around, but they began to feel stuck and unsure of how to best proceed.

They connected with ChicoSTART, and Eva Shepherd-Nicoll, who wasted no time in helping the duo define their next steps. After a one-on-one consultation, Christopher said they had, "a better perspective on what we should be prioritizing, funding opportunities available and comfort in knowing that there is so much support for struggling entrepreneurs trying to build a business in our area. We left the meeting feeling so much more confident that we were on the right track and that we had the support we needed to reach our goals. Eva helped us recognize risks and opportunities we weren't even aware of and did an amazing job of providing guidance and advice to navigate them."

The Lopes figured the best way to accomplish their goals was to sell in bulk to school districts who were looking for CA grown, organic and sustainable sources. The Lopes Family Farms also offer to do in-class presentations to help educate students and staff on where their food comes from, the benefits of duck rice – which include substantial water savings, healthier soil, lower seed costs, and selling the ducks as a secondary crop.

"We've found that the school system is very excited for the opportunity to have farmers educating the kids about regenerative farming especially with the Farm to School movement growing rapidly," said Christopher. "It's been very rewarding hearing feedback from the school districts about how well our rice has been received and their excitement for creating a deeper connection with the kids, where their food comes from, and the regenerative practices being used to grow it."

Quick Mount PV was founded in 2006 to bring cost-effective, code-compliant, waterproof rooftop mounting systems to the solar industry.

Quick Mount PV is committed to integrating sustainable practices into the daily operations of their 90,000 square foot facility in Walnut Creek. They are a Bay Area Certified Green Business and have replaced the floodlights in their parking lot with low-wattage LEDs and de-lamped light fixtures throughout the compound (saving \$14,000 annually). They also re-optimized the HVAC schedules to conserve energy, started on-site composting, established a company garden and implemented a comprehensive Environmental Management System.

As much as possible, they use recycled content aluminum because it requires only 5 percent of the energy needed to produce aluminum from virgin sources and can be recycled indefinitely. Stainless steel raw materials are used in their products when essential to quality and their average recycled content across all metals is 68 percent.

The firm purchased all-electric vehicles for business-related travel, and employees carpool or take public transportation to work. In case they are missing any possible opportunity for improvement, Quick Mount PV management holds quarterly staff meetings to review their sustainability progress.

The Rising Loafer installed low flow faucets and toilets and uses energy and water efficient appliances. They also replaced light bulbs with energy saving units and installed timers on equipment.

The owners are recognized leaders in sustainability and regularly share their green restaurant knowledge and experience with other businesses in the community. They are also training young adults in environmentally-friendly operation of restaurants by partnering with the Job Corp of America and the Berkeley Youth Alternative to offer internships.

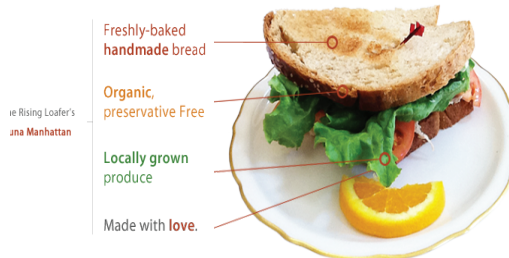
