A recent AGC (Associated General Contractors) workforce survey shows that "88% of construction firms are having a hard time finding workers to hire." New Funding to Support Technical Assistance for Small Businesses

The U.S. Department of the Treasury announced the approval of plans for an additional \$10 million in technical assistance (TA) funding allocated to four states, two territories, the District of Columbia, and one Tribal government under the American Rescue Plan Act's State Small Business Credit Initiative (SSBCI) TA Grant Program. Included in these approvals is the first SSBCI TA grant for a Tribal government.

Part of President Biden's economic agenda, the SSBCI TA Grant Program supports programs that provide legal, accounting, and financial advisory services to qualifying small businesses. Treasury allocated \$200 million by formula to states, the District of Columbia, territories, and Tribal governments for the TA Grant Program and, as of today, has announced awards totaling over \$145 million.

"Today's announcement reinforces President Biden's commitment to invest in small businesses and entrepreneurs," said U.S. Deputy Secretary of the Treasury Wally Adeyemo.

"Providing help to entrepreneurs like accounting services and legal advice is critical to unlocking their potential for growth and to continuing the nation's historic small business boom."

Reauthorized and expanded by the American Rescue Plan Act, SSBCI is a nearly \$10 billion program to support small businesses and entrepreneurship in communities across the United States to promote small business stability, growth, and success- in states, the District of Columbia, territories, and Tribal governments. In addition to the TA Grant Program, Treasury also administers the SSBCI Capital Program, where participating jurisdictions implement credit and equity/venture capital programs to provide capital to small businesses.

The first Tribal government to receive a TA grant is Levelock Village. Approved for \$65,327 in TA grant funding, Levelock Village will use contractors to provide legal and financial advisory services to underserved and very small businesses participating in the Tribe's SSBCI-supported direct investment program (previously approved for up to \$627,054) or seeking other small business support. TA programs like that of Levelock Village – a remote Alaska community accessible only by air or water travel with an economy that relies on local fishing and hunting – will support access to capital and small business support services in Indian Country, which are often banking and TA deserts.

The \$10 million TA investment also included four states, two territories, and the District of Columbia. This includes Minnesota, which was approved for \$1,972,321 in TA grant funding, and will use the Minnesota Small Business Develop-

CALIFORNIA PUBLIC TRANSIT

Nearly \$2 billion going to California public transit

Governor Gavin Newsom announced the approval of over \$1.9 billion to support public transportation throughout the state. The funding was approved by the California State Transportation Agency (CalSTA) and is the first wave of funding from the transit recovery package in the 2023-24 state budget.

As part of Senate Bill 125 (2023), a total of \$5.1 billion will be distributed among regional transportation planning agencies over the course of multiple years. This funding comes with the

flexibility to pay for transit operations or capital improvements. The money announced today will go to 22 agencies, with amounts varying based on regional population.

CalSTA anticipates approving additional allocation packages for remaining planning agencies throughout the summer, totaling nearly \$500 million. The remaining SB 125 funds will be approved annually through fiscal year 2027-28.

"California's commitment to public transit is unwavering, and with billions more in funding in the pipeline – including for zero-emission equipment and operations – we are just getting started in delivering a more sustainable and equitable transit system for the people of California," said California Transportation Secretary Toks Omishakin. "I thank Governor Newsom and our legislative leaders for continuing to prioritize public transit."

The transit recovery package also includes accountability measures to help stabilize transit systems and retool their long-term operations to better align with the needs of the public. As part of that effort, CalSTA has convened the Transit Transformation Task Force to develop policy recommendations to grow transit ridership, improve the transit experience and address long-term operational needs.

More transit dollars on the way

In addition to the transit funding announced today, in April CalSTA put out a call for projects for more than \$900 million in funding through the Transit and Intercity Rail Capital Program (TIRCP). Project applications are due July 23, with an award announcement in October. This follows nearly \$3.5 billion in state funding just last year to expand transit and passenger rail service throughout the state.

Best Practices for Showing Appreciation to Construction Workers

Construction work is physically draining. It means being exposed to the weather as well as potentially dangerous conditions, like great heights and moving traffic. It shouldn't be thankless work as well.

In my experience, however, many construction companies would benefit from making a more active effort to show appreciation to their employees. When construction companies themselves neglect to show appreciation, it contributes to blue-collar employees' common perception that society undervalues their work or does not respect it appropriately.

Staff in the blue-collar industries deserve thanks and praise just as much as those in other sectors if not more. Businesses in the construction industry can help elevate the status of their workers by validating how essential their laborers are. This is particularly critical today, a time when the industry needs to attract and retain workers to meet surging demand.

The Benefits of Showing Appreciation

The first reason business leaders and managers should acknowledge their workers' hard work and dedication is that it boosts their morale. Construction workers rightfully take pride in the buildings and other projects they help to build. Showing appreciation for their work validates that pride. It also cultivates the feelings of ownership that are vital to completing large projects.

In addition, when managers praise their team members' efforts, it increases their motivation and commitment to the company. When managers support and demonstrate loyalty to their employees, they often get it back in return, and retention tends to improve.

Indeed, in one study, turnover was 31 percent less at companies with a strong culture of employee recognition. In another, 53 percent of surveyed workers said they would stay longer at their current employer if their manager would show more appreciation.

In short, granting recognition creates the conditions that lead to higher productivity. Indeed, Gallup has found that businesses with official employee-appreciation programs tend to outperform those without. That's why it's in construc-

tion businesses' own best interest to prioritize gratitude and reward good work.

Yet the Gallup study also found that only one in three American workers report being praised for their good work over the previous week. Furthermore, the authors note that employees at many companies are accustomed to giving their best only to have their efforts ignored.

The Danger of Failing to Show Appreciation

Negative outcomes can result if staff aren't shown adequate appreciation for their work. Employees can become demoralized and lose motivation. It is also common for them to start missing deadlines. Communication can break down, leading to problems with teamwork and collaboration. When workers don't feel respected, their tension and resentment can pollute the entire team's atmosphere. A toxic company culture can develop.

Undervalued employees may also seek opportunities elsewhere. Gallup has found that when employees do not feel like they are receiving adequate recognition, they are two times more likely to plan on quitting in the upcoming year.

Construction companies know how losing employees can negatively affect a job site — the entire project can be delayed. Showing appre-

ciation to employees is clearly important in this industry. But when it comes to construction in particular, what are the best ways to do this?

Basic Ways to Show Appreciation

In my experience, construction companies looking to retain their workers through appreciation must first take care of some basics. Compensation levels need to be competitive, and the same holds true for benefits packages. Today's workers also value autonomy and flexibility, so construction companies that can offer these policies — and back them up in reality — will position themselves well to succeed in today's labor market.

Another essential thing to work on is creating an inclusive workplace. Today, the only way construction companies will fill their ranks successfully is by recruiting people from a wide variety of backgrounds. To attract workers and keep them in their roles, however, these companies must ensure they feel safe and like they belong.

Joyful Art Studio

Joyful Art Studio believes in sharing creative gifts with others to bring the JOY of art to the community.

Owner Cristie Baron opened Joyful Art Studio in April of 2017 as a mobile art studio, hosting special events in classrooms, museums, and art galleries.

She opened her brick-and-mortar art studio in Vacaville in 2021 that provides workshops, youth camps, team building, night events, open studio hours, and classes to artists of all ages in mixed media, acrylic painting, watercolors, and wood signs. Joyful Art Studio is truly where creativity reigns.

While owner Cristie Baron is very grateful for her success, the growth came at a fast pace when the studio opened after the COVID pandemic.

In 2017, she was the sole proprietor with no employees. Her first employee came on board in 2021. By mid-2024, she has 12 part-time employees. Her employees include art teachers as well as an event coordinator.

When she was selected to participate in the Solano-Napa SBDC's Solano Success Accelerator program for an opportunity to receive a \$4,000 COVID-relief grant, she jumped at the chance to not only create a pitch deck for her business but also receive guidance on her business growth from Solano-Napa SBDC advisors.

As part of the accelerator program, she was paired with Solano-Napa SBDC advisor Carolynne Gamble. A fellow artist, Baron felt an instant connection with Gamble and the two have been meeting regularly throughout 2024.

"She is amazing, we are like BFFs," Baron said of Gamble. "I was clueless before and I feel like I should have an MBA now! I've taken all the tips and advice I've learned from her, and my other advisors and I use them as my accountability partners. I always make myself schedule my next appointment with them before I get off the phone because that helps me to set goals with myself."

With Gamble's assistance and encouragement, Baron connected with HR advisor Rhonda Bennett to create an employee handbook. She is also meeting with finance advisor John DeGaetano to solidify pricing for her services. She truly believes the free one-on-one advising with the Solano-Napa SBDC has saved her 'thousands of dollars'.



"Some of the advisors, I meet with once a month, but Carolynne, I meet with almost every week. We connect really well and as an artist herself, she gets the art component and also the business. She listens and is not afraid to tell me where things need to change. She helps me to get the ball rolling and she is my biggest accountability partner."

Baron completed the Solano Success program in early 2024 and received a \$4,000 COVID-relief grant.

Utilizing the pitch deck she created in the accelerator, Baron put together a marketing campaign for Joyful Art Studio that she sent to school districts in the area. Even though it was near the end of the school year and most budgets for next year were already finalized, Baron secured four new contracts in just two months in the spring of 2024.

"I can't even put a price on this. Going through the Solano Success accelerator and working with the SBDC advisors has helped me to really solidify my goals and my purpose, and how to put those things into action.

"I'll be doing this until they kick me out! I've always had a learning mindset, and this is a way I can continue to help others and help my staff to grow. I'm using tools and building these important components that will support all the dynamics of my business."
