Breaking Barriers, Because We Have To

The industry is in dire need for talent. Creating an inclusive culture for women and underreprese

Our industry is facing a competitive war for skilled talent. Employers who aren't contending with workers signing out of the workforce in what some are calling "The Great Resignation," are stuck facing dynamic market shifts and increasing difficulty attracting talent.

Women make up over half of the U.S. population, but only 11% of the construction industry. For skilled frontline workers, that percentage is even less—just 3.4%. While it's projected that 40% of the available workforce is set to retire in the next 10 years, who does that leave to fill

Boston University MBA graduates Teilachanell Angel and Misty Farrell have spent months devising a plausible answer to that question. Their solution: hire more women.

But that answer requires more nuance than it sounds. To integrate more women into the construction workforce—to really tear down barriers that have built up over years of established societal narratives-it's going to take multiple strategies and implementations.

Angel and Farrell, co-authors of Women Breaking Barriers: A Guide to Recruiting, Training and Retaining Women in the Residential Con-

struction Trades, partnered with Building Talent Foundation (BTF). This non-profit organization was founded to advance the education, training, and career progression of young people and people from underrepresented groups. The foundation, led by CEO Branka Minic-who played an invaluable role in the development of the study—coordinates public-private partnerships to advance the sustainable employment goals of stakeholders and communities.

Four Implementation Strategies

Working in tandem with one-another, the co-authors' offer a four-pronged proactive and intentional strategy for hiring and retaining women in

A holistic approach is essential in order for the strategies to work, according to Angel. These are a mutually-reinforcing set of recommendations, and should be treated as a whole.

1. Targeted Diversity Recruiting

The first step is recruiting. Angel and Farrell suggest that employers signal that diverse workers are welcome, and that their recruiting and training materials reflect inclusive imagery and language.

Even in California, infrastructure spending is a climate time bomb. Here's how to fix it.

With the fifth largest economy in the world, California has for decades set the tone for what is possible on climate, with other states and even countries looking to it for bold policy leadership and direction. Yet while Gov. Gavin Newsom continues to tout California as a climate leader, his transportation agencyoperating with little public oversight or ac-

countability—continues to advance harmful projects that will guarantee future increases in emissions.

Nowhere is this contradiction more apparent than in how California is spending its Infrastructure Investment and Jobs Act (IIJA)

The 2021 Bipartisan Infrastructure Law was hailed by the Biden Administration as the biggest investment in climate in U.S. history. It devoted \$1.2 trillion to "rebuild America's

roads, bridges and rail, tackle the climate crisis, advance environmental justice, and invest in communities that have too often been left behind." But states were given enormous latitude in choosing how to spend the hundreds of billions intended for transportation.

Both states and the federal government failed to embrace climate-forward policy to implement the infrastructure law, predictably directing funds to emissions increasing highway building. California's current IIJA spending will result in a net increase of over 2.2 million metric tons of greenhouse gasses above pre-IIJA levels by 2040, according to a recent analysis of IIJA grant awards in California by Transportation for America. Despite ambitious climate legislation and impressive emissions reduction targets, California has dedicated more IIJA funds toward emissions-increasing projects than any state except Florida and Texas.

Driving this increase in emissions is the over

nia's Department of Transportation, Caltrans, is spending on highway expansion. Building more and wider roads encourages more people to drive, undercuts public transit investments and increases greenhouse gas emissions. Transportation is the largest single source of greenhouse gas emissions in California, and one of the few sectors where emissions are still increasing annually. Yet while the state is literally on fire. Caltrans is doubling down on climate arson—a term we do not use lightly.

California's IIJA spending begins to explain why we are off track when it comes to meeting climate goals. What about the rest of the state's \$30 billion in annual transportation spending?

Unfortunately, we don't know. Caltrans does not collect and publicly display data in an accessible manner, and reports to the legislature are piecemeal at best. RebuildingCA.ca.gov, the public dashboard Caltrans uses to report on projects, is the best available resource to

California invests more than \$2 billion to boost public transit

What you need to know: More than \$2.2 billion total is going to support public transportation in communities throughout the state as part of the second wave of funding from the \$5.1 billion transit recovery package in last year's state budget.

California is sending billions of dollars to help boost public transit throughout the state.

Governor Gavin Newsom today announced the approval of an additional \$343 million to support public transportation. The funding was approved by the California State Transportation Agency (CalSTA) and is the second wave of funding from the transit recovery package in the 2023-24 state budget. This is on top of the first wave of \$1.9 billion in funding announced last month

The Governor's commitment to public transit is a key part of his build more, faster agenda delivering critical infrastructure upgrades throughout California. Find projects in your community at build.ca.gov. "Our message to California's transit agencies is clear: we have your backs. California is committed to investing billions of dollars in public transit because millions rely on this clean, safe and reliable way to get to their destinations."

As part of Senate Bill 125, a total of \$5.1 billion spread across multiple years is going to regional transportation planning agencies with the flexibility to pay for transit operations or capital improvements. The remaining SB 125 funds will be approved yearly through fiscal year 2027-28.

Examples of how transit agencies are using this funding includes:

The San Joaquin Council of Governments (SJCOG) is using all of their first year allocation to maintain existing service levels in the region. They are receiving nearly \$45 million in this disbursement using it all on operations expenditures. The Santa Cruz County Regional Transportation Commission (SCCRTC) is using more than \$16

million of their first year disbursement to fund new transit priority infrastructure in their region's highest ridership corridors as well as funding for transit service restoration and targeted service expansion, for an estimated 252,000 service hours.

- El Dorado County Transportation Commission (EDCTC) is using the entirety of their year 1 funding (more than \$10 million) to purchase new zero-emission vehicles and implement a brand new micro transit service within their service area.
- The Council of San Benito County Governments (SBCOG) is investing nearly \$4 million—representing their entire year 1 SB 125 amount—to construct a central transit hub that improves regional connections. This also includes the redevelopment of a bus storage yard, maintenance facility and dispatch center and they'll purchase six new zero-emission buses to replace diesel buses. SBCOG is also committing to reinstating transit services to pre-pandemic levels and implement a new express bus service pilot.

"This critical funding demonstrates California's continued commitment to public transit. Every dollar represents ongoing advancement of a more sustainable and equitable transit system for all Californians," said California Transportation Secretary Toks Omishakin. "The targeted result of this funding is improved mobility for all, and we are grateful for the people-focused actions of Governor Newsom and our legislative leaders supporting transit in our state."

The transit recovery package also includes accountability measures to help stabilize transit systems and retool their long-term operations to better align with the needs of the public. As part of that effort, CalSTA has convened the Transit Transformation Task Force to develop policy recommendations to grow transit ridership, improve the transit experience and address long-term operational needs.

The co-authors emphasize the importance of meeting women where they are—physical and online spaces that women frequent. One approach is to also partner with local community-based organizations that serve women, according to the paper.

Angel and Farrell spotlight many women-oriented pre-apprentice training providers in their study: Oregon Tradeswomen, Women Building Futures, WINTER, and HHW Ohio, for example.

These training programs build a pipeline for talent and building relationships.

2. Providing Wraparound Supports

One of the most difficult challenges facing workers is a lack of supportive infrastructure. Wraparound supports allow learners and workers to show up for opportunities and sustain success. Such supports can help overcome the challenge of retaining women in training and employment.

These support systems, such as childcare infrastructure for women, transportation, mental health counseling, and other challenges that workers face, have a direct correlation to the success of these programs.

Research has found that by providing support systems that actively address barriers to women, equitable access to well paying careers can be achieved. Angel and Farrell found that participants in sectoral programs not only earned more, but were more likely to work, more likely to obtain higher wages, more likely to work in jobs that offered benefits, and had earnings that outpaced those of the control groups.

3. Creating Inclusive & Dignifying Work Cultures

Currently, the biggest barriers women in the industry face are gender narratives, societal beliefs that stereotype women's roles and capabilities, precipitate harmful biases, discrimination, harassment, and sexual harassment, according to the co-authors. "These problems are exacerbated in the construction industry where women are often the 'only one' on the jobsite," says Angel.

Given the industry culture, how do we retain women as employees?

Organizations and employers can start by shifting to a Total Safety culture that embraces psychological safety and trauma-informed management. According to the report, understanding the effects of trauma on individuals, and understanding how that connects to their work life, is essential in safety and retention.

Besides this, organizations can create a culture of allyship. This focuses on building inclusive environments for workers, and encourages them to speak out against bad practices. Angel and Farrell also recommend implementing allyship and behavior-focused training like Bystander Intervention and Manager Training

4. Building Cross-Sectoral Partnerships

Because no one can do it alone, the last step is to partner with training organizations, social services, and community-based organizations that serve women in need.

According to the report, employers should build and mobilize relationships through public-private collaboration of system leaders and stakeholders to align policies, practices, and resources towards a shared vision.

Essentially, leverage meaningful partnerships in which you share a common agenda, shared measurement systems, mutually reinforcing activities, continuous communication, and backbone support organizations.



DEI's Pendulum Swing: Debunking Common Myths about Diversity, Equity and Inclusion in Financial Services

As a person who comes from a disadvantaged community of color, I cannot imagine myself in an institution whose initiatives do not reflect the needs of diverse people. But when institutions lack diversity, they often lack an understanding of how to develop initiatives that address the unique needs of diverse communities. This perpetuates inequities by limiting access to services and eroding the trust of communities of color. Yet many institutions—whether in finance, healthcare, education, or the legal system—remain predominantly white. This lack of diversity is not coincidental; it is the result of legacies of racism, discrimination, and disinvestment that have historically limited social mobility.

Communities of color want to see themselves in the institutions that serve them. We want to establish relationships, and build trust with institutions meant to serve all. However, the Supreme Court of the United States' anti-affirmative action ruling in June of last year-influenced by conservative and republican critics—has contributed to a rise in myths and misconceptions on the need for Diversity, Equity, and Inclusion in our institutions. The termination of race-conscious admissions in higher education has led to an anti-DEI backlash across various sectors, with critics suggesting that considerations on race are no longer necessary to ensure equitable outcomes.

Against the backdrop of this country's persistent racial wealth gap and long history of discriminatory economic practices, the pushback against DEI in financial institutions poses a dangerous threat. The purpose of this blog is to debunk common arguments against DEI in financial institutions, and shed light on the negative implications these misconceptions have on communities of color and our economy as a whole.

Why DEI Matters

During my undergrad at UC Merced, I worked at the university's Multicultural Center as a Scholar Coordinator for the Social Justice Initiatives and Identity Programs department where my role was to promote diversity and a supportive environment for all students and faculty. Through community building workshops and town halls, I listened to students' describe their lack of trust in predominantly white spaces, low confidence in achieving academic success, and the social conditions that limited their upward mobility. Having grown up in a disadvantaged community with limited access to quality services, I understood these feelings deeply.

My experience in the MCC helped me better understand my unique needs in pursuing academic excellence and how this was mirrored in the struggles of others. I made connections with people whose parents also did not go to college, faced language barriers, and experienced financial hardship—all barriers that were unique to the students of color the MCC supported.

The MCC was an essential resource for students of color, helping to address the systemic experience of institutional isolation. Students who felt othered and unwelcomed on campus came to the MCC to find community as well as tailored support to help them overcome the challenges they faced. The experiences of isolation and feeling othered is not a stand alone issue in higher education.

Historic movements for civil rights, social justice, and racial equity paved the way for DEI initiatives like SJI that were vital to me and many students of color during our time at university. These movements also paved the way for DEI frameworks in the workplace. DEI was created as a tool to address the inequitable impacts of institutions that for decades, explicitly barred people of color from access and opportunity, or were not built with people of color in mind. DEI is rooted in the understanding that without targeted resources and support for marginalized communities, institutions will continue to perpetuate historic inequities.

DEI in Financial Institutions

In the financial sector, DEI is designed to address social and economic barriers that limit equitable access to wealth-building and economic opportunity. Race-conscious initiatives are essential to reverse decades of racist policies in our

financial system. These programs aim to include communities of color that have been excluded from traditional banking services and products due to predatory and discriminatory practices, past and present.

After the murder of George Floyd and the "racial awakening" that followed, financial institutions made bold commitments to combat racism in the workplace and provide services for communities of color recognizing the role financial institutions have to play in addressing systemic and economic inequities. Corporate leaders pledged to engage in DEI initiatives including hiring more people of color, investing in historically Black colleges, and removing branding that perpetuates racist stereotypes. Despite this momentary rush to support the movement for racial equity, attention and investments on DEI related-efforts have steadily diminished. This is a disservice to communities of color who continue to struggle to increase their wealth.

DEI's importance in the financial industry must be reaffirmed to combat divisive narratives that seek to maintain the status quo of inequity. Below, I unpack common myths about DEI in financial services, and explore the role of financial institutions in ensuring services continue to evolve in a way that benefits all communities, especially those that have been historically marginalized.

Common Myths About DEI

DEI is no longer needed.

Context: Even as the United States continues to become more racially and ethnically diverse, the racial wealth gap continues to widen. The current racial wealth gap was created from historical discriminatory policies like redlining, segregation, and the barring of people of color from accessing jobs, education, and other services which prevented communities of color from building wealth for decades, and the legacies of this persist. Further, while practices like redlining are now illegal, new forms of financial discrimination continue to emerge. The false assertion that racism is not real in America continues to persist.

Debunked

DEI initiatives that intentionally drive investments into formerly disinvested communities of color are essential to close the racial wealth gap and foster a healthy economy.

Race-conscious laws and policies, a major component of DEI, is needed to close the racial wealth gap. Federal laws like the Community Reinvestment Act, designed to address the impacts of redlining by requiring banks to reinvest in formerly redlined communities, is an example of how DEI can be used as a tool to right these wrongs. While the CRA isn't perfect, its positive impact is undeniable: since 1996, banks covered by the CRA have invested over \$980 billion back into communities of color.

Closing the racial wealth gap requires intentional, race-conscious investments to address deeply rooted economic inequity.

DEI isn't effective in improving financial services for people of color.

Context: Conservative critics and political figures claim DEI programming promotes undeserving people who only advance because of their social status, and does not actually lead to better outcomes for people of color. However, financial work spaces continue to be dominated by predominantly white, male leadership.

Critics also falsely conclude that mandatory diversity training has no effect on employee attitudes, and that employees do not need to learn about implicit biases or diverse perspectives to satisfy the needs of the people they serve.

Debunked

Diversity at all levels of financial institutions are proven to indicate higher diversity in leadership and increased investments in underserved and predominantly minority communities. When banks and other financial services prioritize diversity through race-based policies and programming, not only are they promoting fairness but they also enhance productivity and profitability.

learn how transportation dollars are being spent in your community. But the website includes no information about how these projects contribute to improving safety, increasing opportunity in disadvantaged communities, or addressing climate change.

This lack of accountability allows Gov. Newsom to proclaim himself a climate leader even as his transportation agency fails to live up to his public promises. We need transparency if we are to hold state agencies to account. Assemblymember Pilar Schiavo's Transportation Accountability Act, AB 2086, which Transform is cosponsoring with The Greenlining Institute, will change that.

AB 2086 requires Caltrans to publicly demonstrate how its annual spending on major transportation programs is advancing the vision and goals of the California Transportation Plan. It will streamline existing, fragmented transportation reporting efforts into a uniform and consistent format made publicly available online. This will ensure that the public, law-

makers, and transportation decision-makers can easily access and understand how California's transportation investments impact their communities and align with the state's goals.

Now more than ever, we need more than rhetoric. We can't expect another generational infrastructure investment from the federal government, and in tight budget years to come, California needs to maximize the return on every transportation dollar it spends.

We need to rebuild public trust by demonstrating results to voters through transparent, public reporting. We need to put our money where our mouth is by prioritizing climate-friendly transportation investments. While AB 2086 won't change transportation spending overnight, it is an essential step toward addressing the climate crisis with fundamental good governance. Without it, all we can expect is continued inaction.

We worked with Molly, from the San Francisco SBDC to improve the online store cart and checkout design for mobile. We are able to redesign our welcome email series, and add additional online events promotion through emails. Through the consultation, we gained knowledge on how to assess what is working and what wasn't for Facebook Ads, Google Ads and Google Analytics.

Improved the open rate of our welcome email from 18.4% to 45.3% and improved the clickthrough rate from 1.6% to 7.1%. Increased eCommerce sales by 136.9%. Improved eCommerce conversion rate by 137.2%.

The SBDC team has been surprisingly helpful to our growth trajectory. They are responsive and understanding, and have services and experts that really deliver results that positively impact our top and bottom line.
