

Padilla Announces \$152 Million for Critical Roadway Safety Improvements Across California

U.S. Senator Alex Padilla (D-Calif.) announced that 51 California projects were awarded over \$152 million through the U.S. Department of Transportation’s Safe Streets and Roads for All (SS4A) Grant Program to improve roadway safety. The SS4A program, established by the Bipartisan Infrastructure Law, funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries.

“From children crossing busy intersections to commuters driving to and from work, Californians depend on roadway safety improvements to prevent fatal vehicle collisions,” said Senator Padilla. “Thanks to the Bipartisan Infrastructure Law, California has secured another \$152 million in federal funding to make our streets and roadways safer for the millions of pedestrians, bicyclists, and commuters who rely on them every day. The action plans developed and implemented with this critical funding will save lives and curb serious injuries across all corners of our state.”

Recipients of SS4A grants across California include:

- **Los Angeles County — \$29.81 million:** The LA County Pedestrians Project builds off of Los Angeles’ Vision Zero Action Plan

(VZAP) to implement pedestrian safety improvements at 77 intersections, all of which experience higher-than-average rates of pedestrian fatalities and severe injuries. The project will implement high-visibility crosswalks, curb extensions, and pedestrian signal improvements, including leading pedestrian intervals and rectangular rapid-flashing beacons.

- **City of Long Beach — \$25 million:** The Pacific Avenue Protected Bike Lanes Project will make safety improvements on Pacific Avenue, a 2-mile corridor connecting residents, businesses, and visitors to the LA Metro and local destinations such as Downtown Long Beach, the Long Beach Convention Center, and Long Beach City College. The project will address safety issues to protect all users by adding 2 miles of protected sidewalk-level Class IV cycle track, implementing continuous center medians, removing left-turn lanes to reduce traffic conflicts, and adding raised pedestrian crossings at minor street crossings.
- **City of Alameda — \$16 million:** The Lincoln Avenue/Marshall Way/Pacific Avenue Corridor Improvement

“Under Executive Directive 4, we are continuing to identify opportunities to turn City Hall into an advocate for our entrepreneurs and small businesses and we’re locking arms across our City to ensure these businesses thrive in Los Angeles,” said Mayor Karen Bass. “Our BusinessSource Centers are a one-stop shop in many ways to help business

owners, providing them with essential support that helped secure more than \$18 million in assistance. We will continue this urgent work to support business throughout Los Angeles.”

“We are incredibly grateful for the enthusiastic support from the mayor’s office as we worked to bring Sloomoo Institute’s immersive slime experience to Los Angeles. Their partnership and commitment to fostering creativity and family-friendly entertainment made it possible for us to establish this unique space in such an iconic city,” said Sara Schiller, Co-Founder of Sloomoo Institute.

The City’s BusinessSource Centers are located throughout the city and are ready to provide assistance to small business owners and entrepreneurs free of charge and in multiple languages. In addition to securing millions in capital – a frequently cited barrier to small businesses’ success – more than 2,700 unique services were provided to small business owners, including permitting assistance, financial analysis, business planning and more. Under Executive Directive 4, the City’s departments are changing their

approach to serving small business owners and entrepreneurs to deliver on the Mayor’s vision of City Hall as an advocate and not a barrier to business, including:

Making the permitting process faster and more efficient:

- The Department of Building and Safety created a new Zoning section to allow staff to develop Zoning expertise, improve the quality of work, reduce changes made later in the planning process, and improve efficiency and cost for businesses.
- The Department of Planning (DCP) streamlined clearances for business signage by eliminating redundant intradepartmental referrals in the clearance process.
- As part of the Office of Finance’s Strategic Plan, it is undertaking a comprehensive review of the City’s Tax Ordinances, and will make recommendations to the City Council for modernization in the coming months.

Mayor Breed and City Attorney Chiu Announce New Good Government Reforms to Make San Francisco More Transparent, Accountable, and Efficient

Mayor London N. Breed and City Attorney David Chiu announced new Good Government Reforms targeting the City's contracting process and partners. These reforms include both new Contract Reform legislation and an Executive Directive to city departments to strengthen internal contracting processes. The legislation is co-sponsored by Supervisor Catherine Stefani.

The Comprehensive Contract Reform legislation will:

- Provide additional oversight, accountability, transparency and controls on City contractors and grantees.
- Ensure that public funds are awarded fairly and managed effectively.
- Protect public funds from being misused for improper purposes such as political activity or lobbying City officials.

The Executive Directive 24-04 will work to meet similar goals by directing Departments and staff on how to implement new laws and strengthen oversight under existing laws, standardizing practices across departments, providing fair processes for selecting grantees, guiding departments in monitoring grantee performance, and retaining records to allow for effective audits and investigations.

"Misconduct from those that would wrongfully take advantage of City resources has not been tolerated during my administration, and these new efforts expand on this commitment," said Mayor London Breed. "With the City Attorney's Office and the Controller's Office we have investigated such activity and have acted swiftly and decisively to bring to account bad actors through enforcing existing laws and regulations and creating new and stricter rules to prevent such abuses. Now, we are putting stronger protections in place and expanding the guidance of our Departments to strengthen the public trust

and improve accountability in how our government operates."

"Those who undermine our contracting processes and exploit public resources are not welcome to do business with our City and will be held accountable," said City Attorney David Chiu. "I am proud of our attorneys and investigators who have worked diligently to root out corruption and maintain the integrity of City government. We appreciate the collaboration with the Mayor's Office and Controller's Office on continuing reforms to prevent fraud and the abuse of City resources."

"San Franciscans deserve a city government that responsibly manages their tax dollars and ensures that city services are delivered effectively and reliably," said Supervisor Catherine Stefani. "I'm proud to have authored key reforms to our nonprofit contracting system, codified fair and transparent grant processes, and to now stand with Mayor Breed in advancing these ad-

ditional good governance policies. This Executive Directive is a crucial step toward restoring and strengthening the public's trust in our city government."

More on the Mayor's Good Government Contract Reform & Executive Directive:

The Good Government Contracting Reform legislation will be introduced at the Board of Supervisors meeting on Tuesday September 10. The legislation sets out the following requirements:

- Prevent City contractors from using City funds for political activities by requiring them 1) to keep separate accounts for such activities; 2) keep strict boundaries around staff time, resources and facilities used for such activities; and 3) require disclosure of shared management and programs with political organizations.

- The Department of Building & Safety recently selected a contractor to help develop the new Los Angeles City Permitting System, a platform that will house all data relating to development and building projects, including clearances and code enforcement cases. This new system will provide clear visibility into the status of applications so business owners will understand where their permits are in the process.

Increasing capacity to support business owners and entrepreneurs:

- The Department of Water and Power has hired 30 design engineers and 10 electrical service inspectors since June 2023 to work directly with customers on new or upgraded electric service requests.

Providing more direct assistance for business owners and entrepreneurs:

- In alignment with the objectives of ED4 and to support small businesses in the City, the LAFD has recently expanded its online Help Desk, Virtual Counter, and Preliminary

nary Review services.

- The Bureau of Streets Services opened a public counter in Van Nuys for walk-in assistance for Valley-based street vendors.

Launching and evolving programs to help businesses thrive:

- Announced an extension to the deadline for business owners to apply to continue offering outdoor dining through the popular AI Fresco program, a streamlined permitting process that allows dining on sidewalks, streets and other outdoor spaces. The City of Los Angeles will increase department services and resources to support restaurants, cafes and eateries seeking to transition to the streamlined permanent AI Fresco Outdoor Dining Program from the pandemic-era emergency program.
- In May, the Mayor announced two programs LA Optimized 2.0, a program to help small businesses build and strengthen their digital presence and LAprenuer, a new online learning platform created to equip entrepreneurs with key skills and information



to succeed. Hundreds of Angelenos have enrolled in the programs since their launch.

- In Spring, the Mayor's Office of Business and Economic Development held three Small Business Summits in collaboration with LA County, to help bring resources, speakers, and networking opportunities to small businesses throughout Los Angeles.

Mayor Bass signed Executive Directive 4 in June 2023 to encourage small business creation,

development and growth across Los Angeles. The directive instructed the Mayor's Office of Business and Economic Development to work in collaboration with select City Departments and Bureaus to form the Los Angeles Business Steering Committee to identify barriers to business development and growth.?

Padilla Announces \$152 Million for Critical Roadway Safety Improvements Across California

Project will implement proven safety countermeasures along a 3-mile corridor on the City's high-injury network. The corridor project implements road diets, continuous bicycle facilities, a roundabout, pedestrian beacons, pedestrian and bicycle signals, modernized traffic signals, crosswalk improvements, school frontage improvements, stormwater gardens, disabled parking and loading zones, improved lighting, and bus stop enhancements. This project addresses the four primary collision factors that were responsible for almost 75 percent of crashes along the corridor from 2017 to 2021.

- City of Vacaville — \$11.02 million:** The Safe Streets for Vacaville Project will implement roadway safety and multimodal improvements to facilitate access to key community destinations. The project will address two high-injury corridors within an area in the north part of the city that includes underserved Census tracts. The implementation portion of the project will provide safer connections across I-505, a highway through the north part of the city. Roundabouts and retroreflective backplates will address the high percentage of crashes in the project area that occur at intersections (52 percent) and in dark conditions (40 percent).
- The Housing Authority of the City of Los Angeles — \$10.96 million:** The Wilmington Avenue Vision Zero Revitalization Project will improve safety on Wilmington Avenue, a major North-South arterial road, in South Los Angeles. This project will introduce high-visibility

crosswalks, ADA curb ramps, protected bike lanes, enhanced street lighting, and traffic calming measures along Wilmington Avenue to improve safety. The Rainbow Bridge will also be renovated to include ADA access, improved lighting, and safety features benefiting pedestrians, cyclists, and motorists.

- City of Stockton — \$8.41 million:** The Main and Market Complete Streets Project in Stockton will provide safety improvements for pedestrians and cyclists, who currently have inadequate or nonexistent facilities, while calming traffic along this busy corridor. Improvements include implementing a road diet that converts Main and Market streets from four vehicular lanes to two lanes and installs buffered bicycle lanes, as well as filling gaps in the City's bicycle network. The corridor, located entirely in underserved areas, serves as a vital link between communities east of Highway 99 and Downtown Stockton.
- City of Riverside — \$7.45 million:** The City of Riverside Neighborhood Safety Investment Project will implement safety improvements at 4 of the 6 intersections on its high-injury network. Crash data analysis highlights that the city experiences more total traffic fatalities, and more per capita traffic fatalities, than any other city in the county, including pedestrian fatalities. The project will fill pedestrian gaps with 0.6 miles of new sidewalk; add 16.2 miles of new Class I, II, and III bike lanes; implement intersection improvements such as high-visibility crosswalks and audible pedestrian push buttons at 85 locations; and install speed humps, a traffic circle, and

speed feedback signs as traffic calming treatments in four neighborhoods.

- Sonoma-Marin Area Rail Transit District (SMART) — \$7 million:** The SMART Pathway to Opportunity: Santa Rosa to the Sonoma County Airport Project will close a 4.73-mile gap in the SMART multi-use pathway that allows people to travel to, within, and between the communities and SMART rail stations along its passenger rail and pathway corridor. The additional pathway provides a safe, multimodal alternative to the parallel U.S. Interstate 101. The project will complete an 18-mile continuous, protected, multi-use path between the Town of Windsor and the community of Penngrove in Sonoma County.
- City of Palmdale — \$5.38 million:** The 20th Street East Corridor Improvement Project will make improvements to a 1.92-mile segment of a major 5-lane throughfare. The existing condition has several safety issues that include high posted speed, lack of pedestrian and bicycle facilities in portions of the corridor despite the presence of three schools, poor lighting, and closely spaced/offset intersections. To address these concerns, the City will add a new sidewalk, a new bike lane, an enhanced crosswalk with bulb outs and a pedestrian signal, additional lighting, and a reconstruction of a dangerous intersection.
- City of San Bernardino — \$5.28 million:** The Plan to Action: Revitalizing Roadway Safety in San Bernardino Project will design and construct safety countermeasures at five high-risk locations that have high collision rates and a high incidence of fatalities or severe injuries, or that have proximity to schools

and residential areas. The project implements Proven Safety Countermeasures such as road diets, high-visibility crosswalks, curb extensions, improved sidewalk connectivity, pedestrian refuge islands, traffic signals, buffered bike lanes, pedestrian hybrid beacons, improved pavement friction, modifications of curb ramps to be ADA compliant, and speed limit reductions.

The Bipartisan Infrastructure Law established the SS4A discretionary program with \$5 billion in appropriated funds from 2022-2026. Eligible project types for this round of funding for the SS4A program included projects that will:

- Develop a comprehensive safety action plan (Action Plan)
- Conduct supplemental safety planning to enhance an Action Plan
- Carry out demonstration activities to inform the development of, or an update to, an Action Plan
- Perform planning, design, and development activities for projects and strategies identified in an Action Plan
- Implement projects and strategies identified in an Action Plan that address roadway safety problems

Last December, Senator Padilla announced that California was awarded over \$139 million for 56 projects through the SS4A program. Padilla and the late Senator Dianne Feinstein previously announced \$133 million in SS4A grants for California.

Will AI enhancements also help those new to the estimating profession?

Jennifer Johnson: We know that one in five construction professionals is 55 years of age

or older. While we are fortunate to have such a wealth of experience in the industry, that will not last forever. Faced with the next generation entering the workforce, it is imperative to find a way to ramp up new estimators more quickly. AI can help with that process by creating opportunities for those new to the industry to audit and modify estimates as opposed to starting from scratch.

Given the benefits to estimators of all experience levels, what is ConstructConnect's vision for incorporating AI in its solutions?

Jennifer Johnson: Our preference is to deeply focus on fully meeting the needs of our user segment before expanding into other applications. We are initially focusing our efforts on drywall, interiors, and conceptual estimating for general contractors, but then will move into adjacent space like ceilings and floors. How Is California's Equal Representation in Construction Apprenticeship Grant Cultivating Workforce Diversity?

California created the Equal Representation in Construction Apprenticeship Grant to cultivate workforce diversity. The goal is to increase the number of women, nonbinary individuals, and members of underserved communities in construction apprenticeships to meet the demand for infrastructure creation.

Equal Representation in Construction Apprenticeship Grant Details

The Equal Representation in Construction Apprenticeship Grant is administered by the California Department of Industrial Relations (DIR) and the Division of Apprenticeship Standards (DAS). The organizations are distributing \$25 million to elevate outreach, help cover child-care costs, and strengthen community-building resources to increase opportunities for women, nonbinary individuals, and members of underserved communities to secure high-paying construction jobs and develop career paths.

Equal Representation in Construction Apprenticeship Grant Resources

The dispersal dates for the Equal Representation in Construction Apprenticeship Grant are April 2023 – June 2025.

Supportive resources for childcare

Up to \$3 million in child-care resources will be distributed to each grantee with DAS-registered construction pre-apprenticeship and apprenticeship programs hiring parents with child-care challenges. The funds can be used for childcare support stipends for participants' children.

The supportive resources for childcare awards include:

- **Pre-apprenticeship:** \$5,000 per eligible apprentice in a registered pre-apprenticeship program
- **Apprenticeship:** \$10,000 per eligible apprentice in a registered apprenticeship program

Supportive resources for outreach and community-building

The supportive resources for outreach and community-building depend on the program(s) applied to:

- Up to \$2 million will be distributed to each grantee who applied for only outreach and community-building.
- Up to \$4 million will be distributed to each grantee who applied for child-care, outreach, and community-building resources.

Build California Is an Equal Representation in Construction Apprenticeship Grant Awardee

Build California is a statewide initiative to inspire, engage, and activate the next generation of construction professionals through registered apprenticeships. The workforce development program is led by Associated General Contractors of California (AGC CA) through the AGC Construction Education Foundation (AGC CEF).

In March 2023, Build California was awarded a \$500,000 Equal Representation in Construction Apprenticeship Grant for outreach and community-building. The grant is the largest the AGC CEF or Build California ever received.

Outreach and community-building efforts

The grant funding will help Build California develop and expand outreach communication and programmatic efforts:

- Targeted social media campaigns will reach over 10 million potential workers, including over 10,000 girls, young women, and other underserved individuals ages 12-24 attending at least 24 California high schools and community colleges.
- Underserved individuals will be offered customized career counseling services to place at least 150 workers per year in partner pre-apprenticeship or apprenticeship programs.

- Printed construction career outreach materials and other resources will be given to partner pre-apprenticeship or apprenticeship programs.
- Statewide contractor and employer sponsor match events will ensure program participants who graduate find placement in the next step of their construction careers.
