Continued progress on building the nation’s first high-speed rail system and a strong partnership with the California construction trades union has helped the California High-Speed Rail Authority (Authority) reach another milestone, the creation of more than 14,000 construction jobs since the start of the project.

Progress on the high-speed rail project is the culmination of work between three design-build contractors including Tutor-Perini/Zachry/Parsons, Dragados-Flatiron Joint Venture, and California Rail Builders.

“We are excited to continue the relationship between the Building Trades and the Authority’s

new CEO Ian Choudri,” said Chuck Riojas of the Fresno, Madera, Kings and Tulare Counties Building and Construction Trades Council. “High-speed rail is helping put people to work across the Valley, and that number and need of a skilled labor force will continue to grow.”

In California’s Central Valley, there are more than 25 active construction sites. In addition, 463 of 494 miles have been fully environmentally cleared for the high-speed rail project between the Bay Area and Los Angeles County.

Latinas Contribute \$1.3 Trillion in GDP

Dando vida a la Economía: Giving Life to the U.S. Economy

U.S. Latina GDP Report Indicates Tremendous Growth and Key Drivers

New data from leading researchers indicates that female Hispanics in the U.S. have contributed \$1.3 trillion in 2021 to the gross domestic product (GDP), representing over 50% growth in a decade. The U.S. Latina GDP Report, funded by Bank of America, is first of its kind research on

the significant and rapidly growing economic contribution of the nation’s Hispanic female population. Led by professors Matthew Fienup, Ph.D., California Lutheran University, and David Hayes-Bautista, Ph. D, UCLA Geffen School of Medicine, the Latina GDP report found that U.S. Latina GDP grew at 2.7 times the rate of the GDP of Non-Hispanics between 2010 to 2021. Today, the Latina GDP is larger than the entire economy of the state of Florida.

“This exciting body of work captures the positive growth and contributions that U.S. Latinas from multiple generations have been

making to the U.S. economy, and confirms that Latinas are a driving force. We see similar momentum reflected in our overall business as well as many of the same key drivers found in our own research,” said Jennifer Auerbach-Rodriguez, Strategic Growth Markets & Client Development Executive, Merrill Wealth Management.

“Following notable reports on U.S. and Metro Area Latino GDP, this new report provides much needed attention to the extraordinary contributions of U.S. Latinas. This research reveals that Latinas outpace their gender and ethnic peers in key economic measures, including record levels of Latina workforce participation, educational attainment, and income growth. It reveals that Latinas are drivers of much-needed economic vitality for the nation,” said Dr. Fienup.

The key findings in the U.S. Latina GDP Report include:

Economic Output

- The total economic output of U.S. Latinas is \$1.3 trillion in 2021, up from \$661 billion in 2010, and larger than the econo-

mies of all other states except California, Texas and New York.

- From 2010 to 2021 real U.S. Latina GDP increased a total of 51.1% compared to only 18.8% for non-Hispanic GDP. In other words, the GDP of U.S. Latinas is growing 2.7 times faster.

Labor Force Participation

- From 2010 to 2021, the number of Hispanic females in the U.S. labor force grew a total of 32.9% compared to only 2.7 percent for non-Hispanic females. Despite being just 9.3% of the U.S. population, Latinas are responsible for 30.2% of the growth of the U.S. labor force since 2010.
- From 2000 to 2021, the Latina labor force participation rate increased 7.5 percentage points, while the rate for non-Hispanic females was flat. U.S. Latinas, who started the century with a participation rate a full 5.0 percentage points lower, are now 2.5 percentage points more likely to be actively working than their non-Hispanic female counterparts.

Bipartisan Legislation to Help Lower Costs for Small Businesses

U.S. Senator Jeanne Shaheen (D-NH), Chair of the U.S. Senate Committee on Small Business and Entrepreneurship (SBC), and U.S. Senator Bill Cassidy (R-LA) today introduced the bipartisan Helping Small Businesses to Hedge Risk and Insure against Volatile Expenses (Helping Small Businesses THRIVE) Act. It directs the U.S. Small Business Administration (SBA) to create a program that helps small businesses lock in the cost of commodities, like gasoline or lumber, in order to protect against the future volatile price of energy and other expenses.

“Small businesses are the backbone of our economy and deserve a level playing field. By empowering them to lock in prices for key commodities, we can help small businesses compete with larger businesses, create good-paying jobs and expand their business,” said Chair Shaheen. “I hosted a field hearing in the Granite State last week to discuss the resources available for small businesses to lower their energy costs. Today, I’m proud to introduce bipartisan legislation that

proposes a new resource to help small business owners keep costs under control and secure a vibrant future for our Main Streets.”

“Small businesses are particularly vulnerable to high inflation costs,” said Dr. Cassidy. “The Helping Small Businesses THRIVE Act gives small businesses in Louisiana the tools they need to create jobs, expand operations, and compete with large companies.”

“Businesses grow and create jobs most effectively when they can plan with certainty,” said John Dearie, president of the Center for American Entrepreneurship (CAE). “Sudden changes in business conditions -- especially unexpected increases in critical input costs -- can damage or destroy even the best-run businesses. That’s why large companies commonly protect themselves from input inflation by locking in costs by way of sophisticated financial derivative instruments. But most new and small businesses lack the resources and expertise necessary to effectively protect themselves. The Helping Small Businesses THRIVE Act will address that vulnerability by establishing a new program administered by the

Small Business Administration that will finally provide new and small businesses the input price protection enjoyed for years by large companies. Participating businesses will be able to recapture losses sustained from price volatility regarding critical commodities like gasoline, diesel, natural gas, lumber, and potentially other inputs, that they rely on. The legislation will provide small businesses the price security and confidence they need to plan, thrive, and continue creating jobs. CAE thanks Senators Jeanne Shaheen (D-NH) and Bill Cassidy (R-LA) for their leadership, and looks forward to working with them to ensure swift passage of the legislation.”

“With the cost of doing business rising rapidly in recent years due to inflation, small businesses have been forced to choose between raising their prices or lowering their margins. No small firm wants to be in that position, which is why we’re glad to see a bipartisan solution like the Helping Small Businesses THRIVE Act that will help lower costs and ultimately allow small businesses to better compete with large corporations that are less sensitive to commodity price spikes,”

said John Arensmeyer, Founder and CEO, Small Business Majority.

“It’s no surprise: small companies are inherently the most vulnerable to market fluctuations and to changes in the cost of the inputs that they need to keep their businesses running. Despite representing over 99% of all companies in the United States, and employing roughly half of all private sector workers, small businesses still struggle to leverage that market power to ensure they have a consistent, reliable cost basis for the commodities that underpin their operations. That’s why innovative proposals such as Chair Shaheen’s Helping Small Businesses to Hedge Risk and Insure against Volatile Expenses (THRIVE) Act are so important. This bill is a tremendous first step towards leveling the playing field for small companies across the country, enabling them to responsibly hedge commodity market risks—something historically only available to their largest competitors. Passing It Down: Transferring Knowledge From One Generation to the Next

According to recent U.S. Bureau of Labor Statistics findings, over 2.5 million construction workers are over the age of 55. Associated Builders and Contractors reports that one in five workers will exit the industry in the next few years. With that projected loss of industry expertise looming, leaders are left with the question: How can the industry fill the knowledge gaps with nearly half of its experienced workers retiring?

The construction industry landscape relies on the future of skilled tradespeople. However, the out-

look of the construction industry also depends on those who hold years of industry expertise to pass along this information in preparation for their departure from the field. The balance between trade knowledge and the efficiencies of today’s technology is not just important; it is critical to ensuring the success of the industry. The construction industry should focus its efforts on recruiting younger generations through mentorship programs, promote cross-functional and development training, and embrace technology to improve safety standards, process efficiencies and communication amongst trades.

START THEM YOUNG

Mentorship programs are a key step to engaging younger generations’ interest in the skilled trades. Companies looking to impact the community and share their knowledge with the up-and-coming workforce should collaborate with local high schools to implement various trade programs. These programs are beneficial as they encourage young adults and provide hands-on experiences to pique their interest and prepare them for construction careers.

Skanska USA, for example, provides experiences including internships and days of discovery. Both programs allow students pursuing an edu-

cation in construction, engineering and skilled trades to have a first-hand look at Skanska’s projects and onsite operations, providing them with an experience that goes much deeper than typical classroom curriculum. These programs can be invaluable to students, allowing them to ask questions, test new technology and build necessary career skills. Mentorship programs are essential for sustaining the flow of skilled workers in the industry, enabling students to see the potential paths within the field but also enable businesses to engage in early talent recruiting.

look forward to continuing to work with Chair Shaheen's office to ensure small companies get a fair shake and can continue to power the U.S. economy for generations to come," said Todd McCracken, President & CEO, National Small Business Association.

To help lower costs for small businesses, the Helping Small Businesses THRIVE Act gives small businesses the cost-certainty, time and confidence to build and grow their endeavors. It directs SBA to create a program that allows small businesses to hedge their cost exposure from commodities, like diesel or electricity. The

program offers small businesses options for how to lock in their prices going forward – with a focus on inputs that already have liquid markets and technical assistance to help businesses take full advantage of the program. Along with that guidance, SBA would conduct outreach to small businesses to ensure they are aware of the program and can benefit from it.

The program would first start to lock in costs for gasoline, diesel and up to three additional commodities, with special attention given to standard utilities like natural gas or electricity. Additional commodities and utilities whose costs could be locked in could be added to the program after surveys and feedback from small businesses to

assess which products would be most beneficial to them. Eligible small businesses would exclude traders and financial businesses to ensure this program focuses on small businesses and is not a tool for speculators.

For example:

- Business A locks in \$3.50 per gallon of gasoline for 1000 gallons six months from now, locking in their gas cost at \$3,500 (\$3.50/gallon x 1000 gallons).
- If gas goes up to \$5 per gallon, business A will still pay \$5,000 (\$5.00/gallon x 1000 gallons) at the gas station.

- HOWEVER, because business A locked in a price of \$3.50 per gallon from their hedge through the program, business A would receive a payment of \$1,500 (\$1.50 x 1000), leaving business A's net cost at the \$3,500 they planned for.

Large businesses already protect themselves from inflation by locking in costs through hedging transactions. The Helping Small Businesses THRIVE Act gives small businesses the ability to access those same tools to protect against the volatile price of gasoline and other expenses.

Latinas Contribute \$1.3 Trillion in GDP

Educational Attainment

- The number of Latinas with a bachelor's degree or higher education increased 103% between 2010 and 2021, while the number of highly-educated non-Hispanic females increased only 38.3%. Latina educational attainment is growing 2.7 times faster than that of non-Hispanic females.

Real Income

- From 2010 to 2021, the real incomes of U.S. Latinas grew a total of 46.0 percent compared to only 18.5 percent for Non-Hispanic females. In other words, Latina income growth is 2.5 times that of their Non-Hispanic female counterparts.

"U.S. Latinas coming of age and entering the U.S. labor force are overwhelmingly second- and third-generation Americans. These daughters and granddaughters of immigrants are combining the extraordinary and selfless work ethic of their elders with rapid growth of human capital to give life to the U.S. economy," said Dr. Hayes Bautista.

This data builds directly upon six annual U.S. Latino GDP Reports as well as eight State and a dozen Metro Area Latino GDP Reports released since 2018. Using publicly available data from major U.S. agencies, those reports



reveal that Latinos are drivers of economic growth and a critical source of resilience for broader U.S. economy. They document substantial economic growth premiums enjoyed by Latinos of all genders, relative to non-Latinos in the U.S.

For example, labor force growth of male and female Hispanics in the U.S. is nine times the growth of the non-Hispanic labor force. Real Latino GDP growth is 2.5 times the growth of non-Latino GDP. These premiums exist across a wide range of economic indicators – labor

force participation, educational attainment, real income, consumption, and more.

Mechanical Maintenance/Millwright

The increasing demand for electricians primarily is due to rapid technological advancements, the need to power buildings and devices, and the worldwide shift to renewable energy sources. Sustainable and smart buildings require electricians to install solar panels, electrical systems, and energy-efficient lighting.

HVAC Technicians

According to the U.S. BLS, the 2022-2032 job outlook for heating, ventilation, and air condi-

tioning (HVAC) technicians is 6%. This growth rate is faster than the national average.

The increasing need for energy efficiency, climate control technologies, and green buildings elevates the demand for HVAC technicians. These technicians install, manage, and repair efficient air-handling systems to meet current energy standards, create comfortable homes and buildings, and prevent the spread of airborne pathogens.

Operating Engineers

The U.S. BLS lists the 2022-2032 job outlook for operating engineers as 3%. This growth rate is slightly higher than the national average.

Operating engineers safely and efficiently operate and maintain excavators, bulldozers, cranes, and other heavy construction machinery. These engineers are increasing in demand as infrastructure projects and urban development continue to grow.

Plumbers

According to the U.S. BLS, the 2022-2032 job outlook for electricians is 2%. This growth rate is equal to the national average.

Plumbers are needed to install and maintain the water systems in residential, commercial, and industrial buildings. The growth of new construction projects and the need to align older systems with current standards increase the demand for plumbers.

Mayor London Breed Proposes Legislation to Eliminate License Fees to Support Small Businesses

Mayor London N. Breed, Treasurer José Cisneros, and Supervisors Rafael Mandelman and Aaron Peskin introduced legislation that would eliminate annual license fees for small businesses, making it easier to operate, grow, and open a small business in San Francisco. The announcement builds on Mayor Breed's continued effort to remove barriers and fees to support small businesses citywide.

Drafted in partnership with the Treasurer and Tax Collector's Office, Office of Economic & Workforce Development (OEWD), its Office of Small Business (OSB), and small business stakeholders, the legislation - contingent on the passage of the Proposition M ballot measure - waives 49 annual license fees, providing \$10 million annually in relief to San Francisco small business owners.

"San Francisco has been working hard to remove years of built-up red tape to make it easier to thrive as a small business in our City," said Mayor London Breed. "I have remained committed to changing the narrative that San Francisco is a city of 'No' to getting us to a place where we are a city of 'Yes.' I will continue to work with our departments to find creative ways to remove barriers and fees for our small business owners and ensure that we are building on the tangible progress we have made to bring our City back to life by making it more vibrant, social, and accessible as ever before."

Currently, small business owners pay thousands of dollars in annual fees to operate restaurants, food trucks, bars, and bakeries. There are individual charges for outdoor seating, having billiard tables, and extended hours, among others. A business even incurs an annual fee for things like



a cash register or having candles in their establishment. These fees are charged by individual departments and combined on a unified license bill issued by the Office of the Treasurer & Tax Collector. Should this legislation pass, 91% of restaurants and 87% of bars and nightclubs will no longer receive this annual bill from the City.

"The elimination of numerous annual license fees will truly benefit small businesses in San Francisco," said Laurie Thomas, Executive Director of the Golden Gate Restaurant Association. "We are grateful to the Mayor, the Office of Economic & Workforce Development, and everyone involved for recognizing the needs of our business community and taking action to help us to survive and thrive."

The fees that are proposed to be eliminated have a disproportionate impact on small businesses. Most fees cost the same regardless of the size of the business incurring the cost, and these fees are

generally only paid by smaller businesses, particularly restaurants. In contrast, business taxes are progressive - meaning that smaller businesses pay less than larger businesses.

"Saving small businesses \$10 million a year makes sense for small businesses and for the City," said Treasurer José Cisneros, whose team led the analysis of the current system and the design of the proposed legislation. "This legislation will overhaul our current fee structure that places a disproportionate financial burden on restaurants and nightlife industry businesses."

"Small business is the beating heart of our neighborhoods, and helping these businesses thrive is one of the best strategies to support San Francisco's post-pandemic recovery," said District 8 Supervisor Rafael Mandelman. "This legislation does just that, making good on one of the core elements of 2024's Business Tax Reform - fee relief for our small businesses. I want to thank

and congratulate the City Treasurer and Controller for their work to identify these fees, and I look forward to working with the Mayor and my colleagues on the Board to pass this proposal."

"The Office of Economic & Workforce Development is committed to strengthening and supporting our small business sector," said Sarah Dennis Phillips, Executive Director of the Office of Economic & Workforce Development. "Removing the burden these flat fees impose on our small businesses is fully in alignment with the progressive nature of our tax structure. Our small-scale enterprises and entrepreneurs are driving ground floor revitalization across the City and we want them to thrive in San Francisco."

"If this proposed legislation takes effect, it will be one of the City's most significant reforms to reduce the cost of doing business in San Francisco," said Katy Tang, Director of the Office of Small Business. "The benefits to small businesses will be meaningful and long lasting."

Mayor Breed's Work to Make Starting a Business Easier and Less Expensive


This legislation is one component of a broader strategy championed by Mayor Breed as part of her Roadmap to San Francisco's Future to make it easier to start and grow a business in San Francisco. Her plan calls for creating transparency, streamlining processes, and improving systems to support new businesses opening in San Francisco.

Los Angeles Mayor Karen Bass today announced that the United States Department of the Interior is awarding the City of Los Angeles \$11 million in funding to support the development of Jordan Downs Central Park. The money was secured following efforts from the Housing Authority of the City Los Angeles (HACLA) in partnership with the Mayor's Office. The improvements include a flexible lawn meadow that will double as a soccer/futsal field, two basketball courts, walking paths, lighting, seating options, native landscaping, an accessible community pool and more.

"I want to thank Secretary Deb Haaland for her work in this historic funding for parks across the nation, and for the funding to support the development of Jordan Downs Central Park in Los Angeles," said Los Angeles Mayor Karen Bass. "Los Angeles has been working on a larger revitalization plan of Jordan Downs, and this funding will help to continue the redevelopment and revitalization, doing so in an environmentally friendly way that builds more housing and bike and walking paths across Jordan Downs. Thank you to HACLA for their partnership in this important revitalization and redevelopment."

"The development of Jordan Downs Central Park will be a transformative step in ensuring that Watts has the green spaces and community areas it deserves," said Councilmember Tim McOsler. "This park will be a key part of the revitalization of Jordan Downs, and I can't wait to see families, especially our young residents, enjoying a beautiful space to play, exercise, and thrive. I'm grateful to the U.S. Department of the Interior, HACLA, and our partners for securing this important invest-

ment. Together, we can create environments where every resident can grow and succeed right in their own community."

"The construction of this Jordan Downs Central Park is expected to increase the park area in Watts by 80%, significantly enriching the community's access to green space and recreational opportunities," said HACLA Chief Strategic Development Officer Jenny Scanlin. "With over 45% of the population in Watts under the age of 25, the need for healthy spaces for engagement and play are critical. Over 1,000 residents developed the design of this park based on a set of principles including Community, Safety, Healing, Aspiration, Empowerment, Inclusivity, Justice, and Creativity. This funding was announced by the Department of the Interior and is a part of the single largest grant investment ever from the Land and Water Conservation Fund's Outdoor Recreation Legacy Partnership Program (ORLP). K&S Therapeutic Services, Inc.

Psychotherapy is getting "Uber-ized" by the tech industry. As online mental health platforms like BetterHelp try to turn this highly skilled profession into gig work, some therapists worry that the competition may depress wages and put pressure on their independent relationships with clients.

But Yeshiva Davis, Licensed Marriage and Family Therapist (LMFT), is one step ahead. As the founder of a growing group practice, K&S Therapeutic Services, she is augmenting her business with contract supervision and employment of early-career therapists.

In California, therapists earn their licenses with graduate training and about 3,000 hours of supervised work experience. A more experienced therapist in private practice is allowed to mentor up to six trainees and meets each one weekly.

But not all therapists are interested in supervising. And in government agencies and non-profits that provide therapy, there is no limit on the number of trainees one therapist can supervise. Supervisors may lack the time and energy to mentor so many trainees on top of their other job duties. Davis, though, has discovered that she actually likes to train and teach. Even more than doing therapy itself. She says, "My biggest achievement is happy therapists." BetterHelp can't compete with that.

Before she transitioned to her current line of work, Davis earned an MBA and worked in the

corporate world. Now her knowledge and experience of customer relationship management, marketing, and communications are simultaneously informing her therapy practice and her business strategy. Davis has engaged with folks on radio shows, online workshops, and Facebook Live. She has even been a contributing therapist on Entertainment Tonight, the OWN Network's TV show #LoveGoals, and VH1's Couples Therapy. She also stays connected with her professional network through leadership and service.

Solutions

As she has grown her business over the past few years, Davis has taken advantage of the wealth of resources available at the Pacific Coast Regional Small Business Development Center (SBDC), including one-on-one advising, workshops, and access to capital.
