# Nonprofits seek to get more women into construction trades

Jessica Alvarez Castañeda was sick of low-paying jobs. For years, the 39-year-old mother of four had been "breaking her back for almost nothing" as a cashier, nursing assistant, babysitter, house cleaner and cook.

She was familiar with the skilled trades, which include careers such as carpentry, roofing and painting, because her three brothers worked as pipefitters.

But she hadn't seriously considered pursuing a trade herself until 2022, when she learned that a friend of a friend — also a woman — had completed a training program to become a sheet metal apprentice.

"I had grabbed a hammer before, but I mean, that's pretty much it," said Alvarez Castañeda, who lives in Mountain View, with a laugh. "That was my major concern, that I wasn't going to be strong enough when I'd be expected to do the same work as a man."

Women make up about 11% of the construction industry nationally, according to the Bureau of Labor Statistics, underrepresented for reasons such as misperceptions of the industry, family pressures, and treatment in the workplace. But many California trades provide six-figure sala-

ries within a few years, along with health benefits, a pension and union representation — an attractive career path as women increasingly serve as family breadwinners.

With funding from California's Department of Industrial Relations, training programs and building trades councils are trying to increase the number of women and nonbinary people in a workforce historically dominated by men. They are finding success with targeted recruitment, childcare stipends and one-on-one mentoring.

Alvarez Castañeda signed up for the Trades Orientation Program, hosted by Santa Clara County nonprofit Working Partnerships USA. The program's yearly enrollment of 90 to 100 people is now about one-third women, said Louise Auerhahn, the nonprofit's director of economic and workforce policy, a big jump from just one woman in the pilot 2014 class who "was there because her boyfriend was there, too."

"We've found that because there is such a social stricture that says construction is for men, you have to be really up front about, 'This is for women, and that's who we're looking for,'" Auerhahn said. Working Partnerships USA now creates separate fliers, social media ads, photo campaigns and recruitment events to target women and nonbinary people.

# \$5 Million to Small Businesses to Bring New CHIPS Technology to the Commercial Market

The Biden-Harris Administration awarded nearly \$5 million to 17 small businesses across nine states under the Small Business Innovation Research (SBIR) Program. The SBIR Phase I awards will fund research projects to explore the technical merit or feasibility of an innovative idea or technology for developing a viable product or service for introduction in the commercial microelectronics marketplace. This is the first award for the CHIPS Research and Development Office. The Biden-

Harris Administration is dedicated to getting small businesses the resources they need to thrive and promoting competition to level the playing field.

"As we grow the U.S. semiconductor industry, the Biden-Harris Administration is committed to building opportunities for small businesses to prosper. With today's awards, these 17 businesses will support CHIPS for America's efforts to grow the U.S. semiconductor ecosystem and support our national and economic security," said U.S. Secretary of Commerce Gina Raimondo.

er, chips that take less energy to make, operate and cool, with more functions at less expense.

The award-winning projects were competitively selected from proposals submitted in response to a Notice of Funding Opportunity (NOFO) on

selected from proposals submitted in response to a Notice of Funding Opportunity (NOFO) on multiple topics on research projects for critically needed measurement services, tools, and instrumentation; innovative manufacturing metrologies; novel assurance and provenance technologies and advanced metrology research and development (R&D) testbeds to help secure U.S. leadership in the global semiconductor industry.

These are all Phase I SBIR awards, which are meant to establish the merit, feasibility and commercial potential of the proposed research and development projects. All 17 small businesses will be under consideration for a SBIR Phase II award in Spring 2025. Each Phase II award can be funded up to \$1.910,000.

# 5 strategies manufacturers can start right now to get your products specified

Building product manufacturers know the importance of getting their products specified. Not only is it revenue, but it's the key to forming long-lasting partnerships and future work with builders and architecture firms.

How can a manufacturer increase their chances of getting specified by architects? Derek Guffey is the perfect person to ask. Prior to joining ConstructConnect as the Vice President of Sales for the building product manufacturer segment, Derek was a practicing architect.

"[The] experience I gained as an architect allowed me a unique position to connect building product manufacturers with the architectural community and the design community," he says.

In this recent podcast with Derek, we asked his advice on what a building product manufacturer might do to improve their chances of getting specified. Here's what he had to say.

"Liability, time, and cost. All of your go-to-market activity should be focused around those." Guffey advises.

#### **Regarding Liability**

#### **Know Your Products**

"To get specified, you have to be trusted," Guffey says. "You have to protect that architect from liability. You know, architects carry more liability insurance than doctors do."

#### **Build Relationships**

It takes time to build trust in your brand, and Guffey says networking is an effective way to do it. A good first step is joining industry associations, such as the Construction Specifications Institute (CSI) and American Institute of Architects (AIA).

ConstructConnect, Deltek, and the AIA partner up to publish the Architect's Journey to Specification every year. The guide helps architects and manufactures alike stay up-to-date on trends and approaches within the specification process.

"it's a nice playbook for manufacturers talking about the importance of consultative engagement, strategic engagement, and these designers really value these relationships," he says.

#### **Regarding Cost**

#### **Practice Consistency and Honesty**

The need for trust also expands into cost. Guffey advises manufacturers to be forthcoming on

pricing, and open to input, as early as possible in the design stages.

Being proactive and collaborative about your costs up front can build a stronger rapport with the decision makers, as well as a potential boost to your chances of getting specified.

"I think [being transparent about cost is] just a great tactic to allow them to protect you during the bidding stage and look for reasons why to keep you as products are ultimately being chosen and submitted for that final project."

#### **Final Thoughts**

As Guffey looks to the future, he says it's not just architects that manufacturers need to be selling to. He sees change coming to the industry.

## Nonprofits seek to get more women into construction trades

But introducing women to the trades is just the first hurdle. Research shows that difficulty finding childcare is a central reason that women consider leaving the trades, creating a "massive barrier" to retention, said Beli Acharya, executive director of Construction Trades Workforce Initiative, a nonprofit that works with building trades councils, unions, and community organizations in Alameda, Napa, Contra Costa and Solano counties. California is among the most expensive states for childcare.

"So much of the industry's collective efforts has been, 'Hey, let's get them in,' but a lot of folks are dropping out after the first or second year of being an apprentice, and we're not really achieving the ultimate goal of getting more women in leadership," Acharya said. "Contractors are trying to figure out how to deal with it, unions are trying to figure out how to deal with it, because if we're going to try and target more women, we need to address the needs of women.'

That challenge has prompted new efforts, fueled by the Department of Industrial Relations' Equal Representation in Construction Apprenticeship or "ERiCA" grants, to provide childcare to those most in need. Between 2023 and 2025, the department awarded \$2.1 million to the Construction Trades Workforce Initiative to identify around 200 single-parent apprentices and pre-apprentices to receive between \$5,000 and \$10,000 in childcare support.

Fifty-six people have received Construction Trades Workforce Initiative's stipends so far. more than half of whom are women.

Sharon Brown, a 40-year-old painting apprentice from Oakland and a single parent to three kids, received an \$8,000 stipend from the nonprofit.

The stipend allowed Brown to hire a consistent caregiver to bring her six-year-old daughter to and from school during her early-morning shifts. rather than relying on family.

The stable routine has "helped in ways that I couldn't even imagine," Brown said, in part because her daughter is on the autism spectrum and nonverbal. Recently, the caregiver and her daughter came up with a personal handshake. "To see her remember the handshake and actually execute it out, it's like - wow.

# Four Steps to Reduce Workers' Compensation Costs



Construction work is among the most hazardous occupations, with thousands of workers suffering injuries every year.

Approximately 13% of injured workers are off the job for more than 90 days. These long-term absences not only disrupt projects but also drive up workers' compensation claims disproportionately, burdening businesses with significant financial costs. Compounding the issue, less than 3% of WC claims are flagged for behavioral health conditions, chronic pain and chronic pain with medication use. Yet these cases account for 35% of all WC costs.

The impact of an injury extends beyond physical harm; individuals who experience an injury while working are twice as likely to suffer from serious psychological distress, including anxiety, depression and fear of reinjury or job loss, compared to their uninjured peers. According to historical data from Sentry Insurance, workers struggling with these psychological challenges can take twice as long to return to work and their claims are five times more likely to exceed \$250,000 in WC expenses.

But it doesn't have to be this way. Both businesses and their injured employees can get back on track faster, reducing costs for employers and enhancing personal satisfaction for workers. The key lies in identifying and addressing the factors that keep injured workers off the job for extended periods.



An insurer's data can match the right care at the right time for injured workers that helps them return to work quickly and safely, while controlling costs.

### HOW EMPLOYERS CAN IMPROVE RECOVERY AND RETURN-TO-WORK OUTCOMES

When WC claims involve behavioral health issues, they can quickly escalate, often surpassing the costs associated with early, comprehensive intervention that addresses both physical and psychological needs.

Complex claims with behavioral health elements are also nearly twice as likely to result in litigation. Injuries complicated by psychological distress are also more likely to involve reliance on opioids, which—while sometimes necessary—carry substantial risks of dependence, misuse and increased costs. The potential for multiple surgeries also goes up with these claims, further prolonging recovery. Identifying behavioral health risks early allows for preventative care, reducing the risk of excessive, invasive treatments.

Employers who support injured workers through empathy and communication can help them return to work faster, cutting WC costs and stabilizing the workforce.

Jenny Kan and Valariu Balaban have sold baskets of dog toys on Etsy, but they haven't gotten much traction. Meanwhile, they were frustrated with existing toys, which their dog ignored, so they invented their own food dispensing toy, which they call The Embarker.

Their toy is "sphericon" shaped: It both rolls like a sphere and rocks back and forth like a cone. Together these motions cause it to weave around as it rolls on the ground in a pattern that is more challenging for a dog to follow than a regular ball. It fulfills a dog's natural hunting and foraging instincts. The toy has another unique feature

among food dispensing balls. Its unique design makes it easier for the human to fill with food, but the food doesn't fall out immediately.

#### Challenge

Kan and Balaban participated in the Dream Fund startup training program for new entrepreneurs. To receive the Dream Fund grant, they needed to submit a business plan.

They also wanted to level up their web and social media game because they plan to sell completely through online channels.

### **Lunatics Psycles**

Luis Luna has a passion for customized Harley Davidson motorcycles. In 2001, the U.S. Marine Corps veteran turned his love for bikes into a successful entrepreneurial venture, building, repairing, and selling motorcycles as Lunatic Psycles in Pasadena, CA.

After the COVID pandemic however, Lunatic Psycles was on the brink of closure. Luna had heard about an acquaintance's success working with the PCR Small Business Development Center, so he decided to reach out.

#### Solutions

Luna was paired with PCR SBDC Advisor Jorge Chavarin, who quickly helped assess the three major problems Lunatic Psycles was facing. In addition to the business challenges of the pandemic, Luna needed assistance navigating the loan process. The third issue was probably the most complicated: The building his business was renting was being sold and Luna had a limited amount of time to find a new location.

Chavarin helped Luna sort through his various options for raising capital, including loans and

available grants. Luna was certain he didn't want to incur more debt, so Chavarin walked him through the application processes for the various forgivable PPP loans and grants available. As a result, Luna received a capital infusion of \$9.835.

#### Results

Chavarin also helped Luna strengthen his business. After working through detailed cash flow projections, in-depth SWOT analyses, developing client surveys and implementing feedback, Luna saw a 15% increase in sales revenue.

"My advisor was genuine and truly cared about my business," Luna said. "Without his assistance, my business would have closed and I would not have the means to support my family."

With support from the PCR SBDC and SBDC advisor Jorge Chavarin, Luis Luna was able to keep Lunatic Psycles open and thriving.

"I am beyond grateful," Luna said. "This is one of the best resources I didn't know existed."
