California construction firms plan to hire in 2018, but skilled workers in short supply

"Expecting Growth to Continue: The 2018 Construction Industry Hiring and Business Outlook," contains survey results gathered from the Associated General Contractors of America and Sage Construction and Real Estate.

The report shows that 75 percent of construction firms nationwide plan to expand their payrolls in 2018, based on the feeling that economic conditions will remain strong as tax rates and regulatory burdens fall.

"Construction firms appear to be very optimistic about 2018 as they expect demand for all types of construction services to continue to expand," Stephen E. Sandherr, the association's CEO, said in a statement. "This optimism is likely based on current economic conditions, an increasingly business-friendly regulatory environment and expectations that the Trump administration will boost infrastructure investments."

Sixty percent of California contractors who were polled said they expect the available dollar volume of projects they compete for this year to be higher, and 33 percent expect to hire more than 25 new employees this year.

Another 19 percent figure they'll boost their payrolls by 11 to 25 additional workers, 25 percent plan to add one to 10 new employees and 16 percent expect their staffing to remain the same.

Another 6 percent anticipate staffing cuts.

Despite their hiring plans, 62 percent said they are having a hard time filling both salaried and craft worker positions, and 57 percent expect that trend to continue throughout this year.

Guy Hazen, who owns Construction Owl, an Encino business specializing in home remodeling services, is among the contractors scrambling to find enough skilled craft workers. Those hourly employees include carpenters, electricians, ironworkers and crane operators, among others.

"That's because there's a boom in the industry and there are lots of projects going on," Hazen said recently. "Almost everyone is busy. Real estate demand is very high and interest rates are still low so people can pull money from their home equity to fix up their homes."

The report shows that 60 percent of the construction firms that were polled increased their base pay in 2017 to help recruit and retain workers, while 21 percent paid more overtime and 25 percent provided incentives or bonuses.

Bill Holman, vice president of land development for Christopher Homes and for Rosedale Land Partners — master developer of the 1,250-home Rosedale community in Azusa — said California builders still face significant challenges.

"With regard to the mood about lifting controls or restrictions ... that doesn't apply to California," he said. "Things remain very heavily regulated here for development and growth, and we're seeing that labor markets are pretty tight."

Holman acknowledged that contractors are having a hard time find enough skilled workers. But Christopher Homes, he said, doesn't plan to expand its staffing this year.

"Finding new development projects in Southern California is pretty tough these days," Holman said. "Opportunities are scarce and it takes considerable capital and resources to acquire land and entitle it. We'll hopefully pick off a few opportunities this year — you kind of take them where you find them."

Kenneth Simonson, chief economist for the Associated General Contractors of America, acknowledged that Golden State contractors are still grappling with a myriad of regulatory and environmental hurdles. But he figures plenty of contracting opportunities will be available in 2018 as a result of the recent wildfires that destroyed hundreds of Southern California homes, construction of the high-speed rail line and ongoing infrastructure projects at Los Angeles International Airport and other regional airports.

"Construction firms in California are extremely optimistic about the outlook this year," he said.



The results are in, and this year's best jobs may look a little different from years past.

Job search site Indeed has crunched the numbers to help identify the jobs workers love most. In particular, the site focused on salary, looking at jobs that have a baseline salary of \$75,000, and abundance of opportunity—positions whose listings have seen the most growth on the Indeed site since 2014.

As is to be expected, tech jobs performed well, but this year's list saw some industry diversity. The No. 1 spot for 2018 went to commercial project manager, which landed at No. 19 last year. According to Indeed's findings, commercial project managers, who are responsible for developing and overseeing profitable projects and contracts from inception to completion, earn an average base salary of \$81,023. Job postings for these roles have grown 277% in the last three years.

Full stack developer, the No. 1 job in 2017, came in at No. 2 this year. Computer vision engineer, machine learning engineer, and preconstruction manager rounded out the top five.

Preconstruction manager, the individual responsible for planning a construction project prior to its start, is a newcomer to the list. In fact, 16 jobs are new entries on 2018's ranking. They draw from a range of industries, including construction and healthcare.

NYC construction likely to avoid worst effects of steel tariff

The New York City construction industry would likely escape the worst effects of a tariff on foreign steel that was proposed by President Donald Trump last week, according to experts interviewed by Crain's.

Trump floated the idea of slapping a 25% tax on steel and 10% on aluminum produced abroad during a meeting with industry executives. The move, if it is actually put in practice, would shield domestic producers against competition from abroad but also raise prices for other sectors of the U.S. economy that rely on the metals.

In the five boroughs, however, commercial office developers using structural steel for the skeletons of their towers would likely not see a significant change.

"In the New York market, almost all steel comes from the U.S.," said Brian Raff, director of government relations for the American Institute of Steel Construction, a structural steel trade group that has said Trump's proposed tariff does not go far enough in curbing imports.

General contractors and developers could still feel some effects, however, because sapping foreign competition would give domestic producers more leeway to set prices.

"Will this allow domestic steel mills to raise prices a little bit? Probably," said Paul Brancato, general manager of Ideal Steel in the Bronx. "But I don't think this is going to be a great boon to the industry where we'll see steel mill after steel mill opening."

Any changes to the supply chain worry general contractors, especially for projects in motion or those ordering large or unusual pieces that often come from abroad.

"It will drive up the costs of steel on projects that already have agreed-upon budgets," said Lou Coletti, head of the Building Trades Employers' Association. "And it will cause scheduling delays in deliveries and drive up construction costs."

The city is already home to the priciest construction in the world, and the cost of steel alone rose about 5% between 2015 and 2017, according to a report from Turner & Townsend.

As for the proposed 10% tariff on aluminum imports, the Beer Institute said the move would cost the industry about \$340 million a year, or roughly 1 cent for every can sold.



Jerry Brown's Rail Fantasy Keeps Getting Pricier

"That's bulls**t," Gov. Jerry Brown told a group of union leaders in Sacramento this week as he addressed the latest bad news about his pet project to build a bullet train connecting San Francisco with Los Angeles. The union folks probably loved the tirade, given that the proposed rail system is more of a make-work project for union members than a transportation system. But the governor's promise that the state can build the railway if "we don't let these small-minded people intimidate us into lowering our expectations" rang a bit hollow.

Brown said he is "so tired of all the nonsense that I read in the paper and you hear from other politicians." But the latest nonsense comes from his own High-Speed Rail Authority, which released its latest business plan. The project already is over budget and behind schedule. The new plan bumps the predicted costs from \$63 billion to \$77 billion — and delays the opening date by four years, to 2033.

Those costs will surely grow even more given that the current overruns are taking place on the flat, easy-to-build section of the system through the Central Valley. Just wait until the real engineering challenge is confronted, as rail planners figure out how to take the train through the Tehachapi Mountains separating the valley from Southern California.

Look at other major California infrastructure projects for an idea of realistic cost overruns. Rebuilding the eastern span of the Bay Bridge, following the Loma Prieta earthquake in 1989, was 2,500 percent (that's not a typo) over the original estimate and wasn't completed until 2013.

Apparently, it's "small minded" for Californians — including one of the authors of the 2008 statewide initiative that secured \$9.95 billion in funding for the train project — to question the overruns, delays, and failure of the latest plan to live up to the promises made to voters. That author, former Sen. Quentin Kopp, remains an advocate of high-speed rail in concept, but he calls the current alignment "foolish" and said "it is almost a crime to sell bonds and encumber the taxpayers of California at a time when this is no longer high-speed rail."

Kopp is right. To make it feasible, rail boosters created a route alignment that shares tracks with commuter trains (the blended route) on the peninsula south of San Francisco and in the Los Angeles area. It's highly unlikely that it will connect the state's two megalopolises anywhere near the promised time of 2 hours and 40 minutes given how slow the trains will go in these areas.

It's magical thinking to expect the project to do that as 2008's Proposition 1A promised – with no operating subsidies and at an affordable price

funded by private investment. Investors have run for the hills and the subsidies are a given. And why is this project even needed? I just took a Southwest Airlines flight from Sacramento to Los Angeles for under \$100 roundtrip (on a special deal, which you can regularly find) with a flying time of a little more than an hour. It's not as if Californians have no options to travel up and down the state.

The project has been unable to tap federal funds now that the Obama administration, which supported the project, is history. The initial bond funding is a pittance of the project's estimated total cost. The auctions of cap-and-trade credits are another funding source, but even the Democratic-controlled Legislature is reluctant to open up those spigots given its other priorities.

But Brown has a plan: "I'll tell you how we're going to fund the railroad. We're going to take back the Congress and then a Democratic Congress is going to put the high-speed rail in the infrastructure bill and then we'll get that trillion dollars and we'll put America back to work." That's far from a certainty — and it's a bizarre way to plan for a major investment. Let's just start building and hope that the political winds change and a new Congress will dole out the money. OK, I guess.

Falling Victim to Trends

What they fail to see is following the competitors makes the clients brand them as copycats rather than someone with an exclusive identity and purpose.

"Avoid falling victim to trends. Stay true to your message, mission and create techniques to draw the attention of others towards it. Businesses need time and patience to create their appeal amongst the customers. Many big businesses first started as a niche product or service which gradually advanced to a simpler and widely accepted unit," notified Dr. Bala V Balachandran, Founder, Dean and Chairman, Great Lakes Institute of Management.

Failing to Develop a Comprehensive Revenue Model

Everyone who is in business wants to make a profit. Most also know about the product or service which they are selling and it's making cost. What often, gets ignored is creating a revenue model which is much more important than learning to do a transaction. The lifetime worth

of a client has to be made clear in the mind, so does a sketch on capturing that worth over time.

"It is a very common misconception that an entrepreneur needs to find new customers once a buyer buys their products. In its place, one should deeply work on the ways to optimize and extend the relationship with the existing clientele. This helps in faster growth," suggested Biswanath Bhattacharya President Federation of Small and Medium Industries (FOSMI).

The secret of writing a fine revenue model is similar to that of drafting a business plan. All one needs is to foretell all the products in the next decade and make the patron's journey easy in dealing with your company. The model can alter with time, but the map and direction remain same.

Getting Egoistic

Ego and arrogance of the top management of a company have brought the doom of more businesses than any other factor. When many big corporates have collapsed because of these two vices, it is very important for the leaders of fledgling ones to try hard and avoid indulging in them.

"One of the best qualities of good leaders and managers is to admit their faults and flaws and try to make up for the damage done. Killing the ego is the first step in doing so," prescribed Kuldip Maity, Founder, Village Finance.

Let these four warnings keep you from making the same mistakes most first-time entrepreneurs make. Invest the time to grow your business and plan for the future the right way.

Jerry Brown's Rail Fantasy Keeps Getting Pricier

That approach is reminiscent of the one detailed by flamboyant former Assembly Speaker Willie Brown. In a July 2013 San Francisco Chronicle column addressing \$300 million in cost overruns for the city's Transbay Terminal, he argued, "If people knew the real cost from the start, nothing would ever be approved. The idea is to get going. Start digging a hole and make it so big, there's no alternative to coming up with the money to fill it in."

The bullet-train project epitomizes such publicsector cynicism. Proposition 1A offered myriad detailed promises to woo skeptical voters. A superior court initially halted the sale of the bond funds to begin digging the hole, so to speak, because the authority wasn't following requirements that it identify enough cash to complete the first 300-mile segment. Unfortunately, a higher court ultimately gave the project the go-ahead. That shouldn't be a shock to Spectator readers, who are used to hearing the absurd promises made by politicians. But voter initiatives are written laws, not suggestions.

In recent months, the governor's other large infrastructure boondoggle has also run into trouble. Brown wants to build two giant 35-mile tunnels underneath the Sacramento-San Joaquin Delta to bring water from the relatively rainy north to arid Southern California. It's a way to keep water flowing even when the state shuts the pumps to protect the endangered Delta smelt.

"The \$17-billion bill for the twin-tunnel version was supposed to be paid by the San Joaquin Val-

ley agricultural districts and Southland urban agencies," reported the Los Angeles Times. "But the farm districts have for the most part declined to open their wallets, saying the water is too expensive for them." Not all of the urban agencies are all that excited about paying for it, either.

These projects are unfathomable given that Brown last year insisted that Californians raise gas taxes — or else their roads and bridges will continue to crumble. As Brown leaves the public stage after decades of elected office, he is reduced to hurling insults at Californians who make perfectly reasonable criticisms of costly projects that divert money from far more pressing priorities. In my view, that's very definition of small-minded BS.
